1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that her naval record be corrected to show that Petitioner's 14 July 2022 reenlistment contract reflected Full Time Support (FTS) status vice Active Component.

2. The Board, consisting of **Constant 1**, **Constant 1**, and **Constant 1** reviewed Petitioner's allegations of error and injustice on 24 October 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 14 July 2022, Petitioner erroneously reenlisted in the U.S. Navy for 6 years with a new contract expiration date of 13 July 2028 and RADO months/days of 000/000.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an error warranting the following corrective action. The Board concluded that Petitioner is an FTS (Branch Class 32) Sailor. Petitioner reenlisted on 14 July 2022 for 6 years, however the branch class was erroneously entered as USN/11 rather than USNR/32 –FTS.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner executed an immediate reenlistment contract (NAVPERS 1070/601) on 14 July 2022 in the U.S. Naval Reserve (Branch class USNR) vice U.S. Navy (Branch class USN) with a RADO months/days of 072/000 vice 000/000.

A copy of this report of proceedings will be filed in Petitioner's naval record.
