1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 5 October 2021 for 4 years, was eligible for and received a Zone B Selective Reenlistment Bonus (SRB), and was eligible to transfer his education benefits.

2. The Board, consisting of **Construction**, **Construction**, and **Construction** reviewed Petitioner's allegations of error and injustice on 13 August 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 1 October 2015, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 30 September 2019 and Soft EAOS (SEAOS) of 30 September 2021; "[t]raining in the six-year obligor (6YO) program for Nuclear Field/NF rating. I understand that this extension becomes binding upon execution, and may not be cancelled, except as set forth in MILPERSMAN 1160-040." refer to NAVCRUIT1133/52 Annex A to DD Form 4 dated 14 Nov 24 specific bonus guarantee."

b. On 28 May 2016, Petitioner got married.

c.	On 9 February 2018, Petitioner transferred from	, and arrived to

d. On 19 September 2018, Petitioner's first dependent child was born.

e. On 5 October 2018, Petitioner reenlisted for 6 years with an EAOS of 4 October 2024 and received a Zone A SRB.

f. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

g. In July 2020, Petitioner was awarded Navy Enlisted Classification (NEC) N14S.

h. On 19 April 2021, Petitioner's second dependent child was born.

i. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 005/FY21), a Zone "B" SRB with an award level of 7.0 (\$100,000 award ceiling) for the EMN(SS)/N14O/S, rate/NEC was listed.

j. On 1 October 2021, Petitioner entered Zone B.

k. On 25 October 2021, Petitioner was issued official change duty orders (BUPERS order: with required obligated service to March 2025, while stationed in

with an effective date of departure of February 2022. Petitioner's ultimate activity was for duty with an effective date of arrival of 24 March 2022 with a Projected Rotation Date of March 2025. Obligated service to March 2025, is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.

l. On 17 January 2022, Petitioner signed an agreement to extend enlistment for 5 months with an SEAOS of 4 March 2025 in order to incur sufficient obligated service to execute BUPERS order

m. On 15 March 2022, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.

n. On 15 March 2022, Petitioner transferred from **March 2022**, and arrived to **March 2022** for duty.

o. On 7 August 2024, Petitioner's Benefits for Education Administrative Service Tool listed no dependents.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 1 October 2021, Petitioner entered Zone B. At that time, a Zone B

SRB was authorized in accordance with reference (c). On 25 October 2021, Petitioner was issued BUPERS order: with required obligated service to March 2025. On 17 January 2022, Petitioner signed an agreement to extend enlistment for 5 months to meet the OBLISERV. The Board determined that Petitioner could have reenlisted upon entering Zone B in accordance with reference (b). On 5 October 2021, Petitioner would have been eligible to reenlist for 4 years and receive a Zone B SRB. Furthermore, Petitioner would have been eligible to transfer his education benefits to his dependents.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 5-month agreement to extend enlistment (NAVPERS 1070/621) executed on 17 January 2022 is null and void.

Petitioner was discharged 4 October 2021 and reenlisted on 5 October 2021 for a term of 4 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "7.0" (\$100,000 award ceiling) for the EMN(SS)/N14S, rating/NEC. Remaining obligated service to 4 October 2024 will be deducted from SRB computation. Additionally, Navy Personnel Command is authorized to align transfer of education benefits with the 5 October 2021 reenlistment. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will <u>not</u> take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will <u>not</u> be funded by the BCNR's Claims Line of Accounting (LOA). **The second seco**
