1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 26 July 2022 for 3 years, was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 5 May 2015, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 4 May 2019 and Soft EAOS (SEAOS) of 4 May 2021; "[t]raining in the Nuclear Field Program and advancement to E4 per MILPERSMAN Articles 1160-040 and 1510-030. I understand that this extension becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN Article 1160-040. In particular, I understand that when I accept advancement to E4, 12 months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training."

b. On 14 August 2017, Petitioner transferred from **14** August 2017 for duty.

c. On 26 November 2018, Petitioner reenlisted for 6 years with an EAOS of 25 November 2024 and received a Zone A SRB.

d. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

e. In September 2020, Petitioner was awarded Navy Enlisted Classification (NEC) N14S.

f. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 003/FY21), a Zone "B" SRB with an award level of 7.0 (\$100,000 award ceiling) for the EMN(SS)/N14O/S, rate/NEC was listed.

g. On 8 March 2021, Petitioner was issued official change duty orders (BUPERS order: ) with required obligated service to December 2024, while stationed in Summer , with an effective date of departure of July 2021. Petitioner's intermediate (01) activity was summer, for temporary duty under instruction with an effective date of arrival of 23 August 2021. Petitioner's ultimate activity was , for duty with an effective date of arrival of 11 December 2021 with a Projected Rotation Date of December 2024. Obligated service to December 2024, is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.

h. On 5 May 2021, Petitioner entered Zone B.

i. On 12 July 2021, Petitioner transferred from **Example 1**, and arrived to **Example 2** on 24 August 2021 for temporary duty.

j. On 22 November 2021, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.

k. On 22 November 2021, Petitioner transferred from **and arrived to** on 22 November 2021 for duty.

1. On 14 April 2022, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows a 1-month agreement to extend enlistment with an SEAOS of 25 December 2024.

m. In May 2022, Petitioner was awarded NEC 805A.

n. In accordance with reference (d), FY22 SRB Award Plan (N13SRB 003/FY22), a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the EMN(SS)/N14O/S, rate/NEC was listed.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 8 March 2021, Petitioner was issued BUPERS order: with required obligated service to December 2024. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 5 May 2021, Petitioner entered Zone B. On 14 April 2022, NSIPS/ESR shows a 1-month agreement to extend enlistment to meet the OBLISERV. The Board determined that Petitioner should have signed a NAVPERS 1070/613 vice extension of enlistment. On 26 July 2022, Petitioner would have been eligible to reenlist for 3 years and receive a Zone B SRB.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 1-month agreement to extend enlistment (NAVPERS 1070/621) operative on 26 November 2024 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 12 July 2021 agreeing to extend enlistment for 1 months for OBLISERV to December 2024.

Petitioner was discharged 25 July 2022 and reenlisted on 26 July 2022 for a term of 3 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "8.5" (\$100,000 award ceiling) for the EMN(SS)/N14S, rating/NEC. Remaining obligated service to 25 November 2024 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will <u>not</u> take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will<u>not</u> be funded by the BCNR's Claims Line of Accounting (LOA).
