1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted for 4 years and was eligible for and received a Zone B Selective Reenlistment Bonus (SRB) on 31 May 2023.

2. The Board, consisting of ██████████, ██████████, and ██████████ reviewed Petitioner's allegations of error and injustice on 13 November 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 28 April 2017, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 27 April 2021 and Soft EAOS of 27 April 2023; "[t]raining in the Nuclear Field. MILPERSMAN 1510-030 and MILPERSMAN 1306-500, 1306-502, and 1306-504 (NF) are governing directives. Advancement to Rate and Grade per MILPERSMAN 1430-010. I understand that this extension of active service becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN 1160-040 and 1510-030. In particular, I understand that when I accept advancement to E4, 12 months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training."

b. In April 2019, Petitioner was awarded Navy Enlisted Classification (NEC) N23O.

- c. On 21 March 2019, Petitioner transferred from [REDACTED] and arrived to [REDACTED] on 30 April 2019 for duty.
- d. On 10 August 2019, Petitioner reenlisted for 6 years with an EAOS of 9 August 2025 and received a Zone A SRB.
- e. In accordance with reference (b) announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must have reenlisted within 365 days of their EAOS (as opposed to 270 days required) except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.
- f. In August 2021, Petitioner was awarded NEC N71Z.
- g. In accordance with reference (c) FY23 SRB Award Plan (N13 SRB 001/FY23), a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the ETN(SW)/N23O/S, rate/NEC was listed.
- h. On 29 December 2022, Petitioner was issued official change duty orders (BUPERS order: [REDACTED]) with required obligated service to May 2026 with an effective date of departure of April 2023. Petitioner's ultimate activity was [REDACTED], [REDACTED], [REDACTED] for duty with an effective date of arrival of 31 May 2023 with a projected rotation date of May 2026. Obligated service to May 2026, is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.
- i. In February 2023, Petitioner was awarded NEC N23S.
- j. On 13 February 2023, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows a 9-month agreement to extend enlistment with a Soft EAOS of 9 May 2026.
- k. In accordance with reference (d) FY23 SRB Award Plan (N13 SRB 002/FY23), a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the ETN(SW)/N23O/S, rate/NEC was listed.
- l. On 20 April 2023, Petitioner transferred from [REDACTED] and arrived to [REDACTED] on 31 May 2023 for duty and entered Zone B on 28 April 2023.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an error warranting the following corrective action. The Board concluded that on 29 December 2022, Petitioner was issued orders 3632 with required obligated service to May 2026. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 13 February 2023,

NSIPS/ESR shows a 9-month agreement to extend enlistment to meet the obligated service. On 28 April 2023, Petitioner entered Zone B. The Board determined that Petitioner should have signed a NAVPERS 1070/613 vice extension of enlistment and would have been eligible to reenlist for 4 years and receive a Zone B SRB on 31 May 2023.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 9-month agreement to extend enlistment (NAVPERS 1070/621) operative on 10 August 2025 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 13 February 2023 agreeing to extend enlistment for 9 months for obligated service to May 2026.

Petitioner was discharged 30 May 2023 and reenlisted on 31 May 2023 for a term of 4 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "8.5" (\$100,000 award ceiling) for the ETN(SW)/N23S, rating/NEC. Remaining obligated service to 9 August 2025 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will not take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will not be funded by the BCNR's Claims Line of Accounting (LOA). [REDACTED] at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive. Contact the Assistant Nuclear Enlisted Program Manager, N133D, [REDACTED] [REDACTED] concerning SRB payment.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
