1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted for 3 years and was eligible for and received a Zone B Selective Reenlistment Bonus (SRB) on 27 May 2023.

2. The Board, consisting of **Example**, **Example**, and **Example**, and **Example** reviewed Petitioner's allegations of error and injustice on 19 November 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 24 February 2015, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 23 February 2019 and Soft EAOS of 23 February 2021; "[t]raining in the Nuclear Field. MILPERSMAN 1510-030 and MILPERSMAN 1306-500, 1306-502, and 1306-504 (NF) are governing directives. Advancement to Rate and Grade per MILPERSMAN 1430-010. I understand that this extension of active service becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN 1160-040 and 1510-030. In particular, I understand that when I accept advancement to E4, 12 months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training."

b. In April 2017, Petitioner was awarded Navy Enlisted Classification (NEC) N24O.

c. On 7 April 2017, Petitioner transferred from and arrived to and arrived to on 8 May 2017 for duty.

d. On 26 January 2018, Petitioner reenlisted for 6 years with an EAOS of 25 January 2024 and received a Zone A SRB.

e. In accordance with reference (b) announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required) except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

f. In accordance with reference (c) FY21 SRB Award Plan (N13SRB 002/FY21), a Zone "B" SRB with an award level of 7.5 (\$100,000 award ceiling) for the EMN(SW)/N24O/S, rate/NEC was listed.

g. On 5 January 2021, Petitioner was issued official change duty orders (BUPERS order: 0051) with required obligated service to May 2024 with an effective date of departure of April 2021. Petitioner's ultimate activity was for for duty with an effective date of arrival of 28 May 2021 with a projected rotation date (PRD) of May 2024. Obligated service to May 2024, is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.

h. On 24 February 2021, Petitioner entered Zone B.

i. On 9 December 2021, Petitioner was issued official modification to change duty orders (BUPERS order: 0051) with required obligated service to May 2025 with an effective date of departure of April 2022. Petitioner's ultimate activity was

for duty with an effective date of arrival of 29 May 2022 with a PRD of May 2025. Obligated service to May 2025, is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.

j. On 24 April 2022, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows a 16-month agreement to extend enlistment with a Soft EAOS of 25 May 2025.

k. On 27 April 2022, Petitioner transferred from	and arrived to
on 27 May 2022 for duty.	

## Subj: REVIEW OF NAVAL RECORD ICO XXX-XX-

1. In accordance with reference (d), FY23 SRB Award Plan (N13 SRB 002/FY23), a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the EMN(SW)/N24O/S, rate/NEC was listed.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an error warranting the following corrective action. The Board concluded that on 5 January 2021, Petitioner was issued orders 0051 with required obligated service to May 2024. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 24 February 2021, Petitioner entered Zone B. On 9 December 2021, Petitioner was issued official modification to BUPERS order: 0051 with required obligated service to May 2025. On 24 April 2022, NSIPS/ESR shows a 16-month agreement to extend enlistment to meet the obligated service. The Board determined that Petitioner should have signed a NAVPERS 1070/613 vice extension of enlistment and would have been eligible to reenlist for 3 years and receive a Zone B SRB on 27 May 2023.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 16-month agreement to extend enlistment (NAVPERS 1070/621) operative on 26 January 2024 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 24 April 2022 agreeing to extend enlistment for 16 months for obligated service to May 2025.

Petitioner was discharged 26 May 2023 and reenlisted on 27 May 2023 for a term of 3 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "8.5" (\$100,000 award ceiling) for the EMN(SW)/N24O, rating/NEC. Remaining obligated service to 25 January 2024 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will <u>not</u> take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will<u>not</u> be funded by the BCNR's Claims Line of Accounting (LOA). at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive. Contact the Assistant Nuclear Enlisted Program Manager, N133D, <u>Concerning SRB payment</u>.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
