1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted for 5 years and was eligible for and received a Zone B Selective Reenlistment Bonus (SRB) 21 October 2022.

2. The Board, consisting of **Constant of Action**, **Constant of Action**, and **Constant of** reviewed Petitioner's allegations of error and injustice on 26 November 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 28 April 2016, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 27 April 2020 and Soft EAOS of 27 April 2022; "[t]raining in the Nuclear Field Program, and advancement to E-4 per MILPERSMAN Articles 1160-040 and 1510-030. I understand that this extension becomes binding upon execution, and thereafter may not be cancelled, except as set forth MILPERSMAN Article 1160-040. In particular, I understand that, when I accept advancement to E-4, 12 months of this agreement may not be cancelled, whether or not I complete Nuclear Power or Advanced Training."

b.	On 11 April 2018, Petitioner transferred from	and arrived at
	on 25 April 2018 for duty.	

c. On 28 September 2018, Petitioner transferred from and arrived to and arrived to on 14 December 2022 for duty.

d. In accordance with reference (b) announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required) except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

e. In February 2021, Petitioner was awarded Navy Enlisted Classification (NEC) N13S.

f. In accordance with reference (c) FY21 SRB Award Plan (N13SRB 005/FY21), a Zone "B" SRB with an award level of 9.5 (\$100,000 award ceiling) for the ETN(SS)/N13O/S, rate/NEC was listed.

g. On 29 September 2021, Petitioner was issued official change duty orders (BUPERS order: ) with required obligated service to August 2025, while stationed in

with an effective date of departure of April 2022. Petitioner's intermediate (01) activity was activity with an effective date of arrival of 20 August 2022 with a projected rotation date (PRD) of August 2025. Obligated service to August 2025, is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.

h. On 20 October 2021, Petitioner reenlisted for 4 years with an EAOS of 19 October 2025 and received a Zone A SRB.

i. In December 2021, Petitioner was awarded NEC N33Z.

j. On 29 March 2022, Petitioner was issued official modification to change duty orders (BUPERS order: ) with required obligated service to February 2026, while stationed in with an effective date of departure of September 2022. Petitioner's intermediate (01) activity was for temporary duty under instruction with an effective date of arrival of 17 October 2022. Petitioner's ultimate activity was for duty with an effective date of arrival of 4 February 2023 with a PRD of February 2026.

k. On 28 April 2022, Petitioner entered Zone B.

l. On 5 May 2022, Petitioner was issued official modification to change duty orders (BUPERS order: ) with required obligated service to April 2026, while stationed in

with an effective date of departure of November 2022. Petitioner's ultimate activity was a second of April 2026. Obligated service to April 2026 is required for 14 December 2022 with a PRD of April 2026. Obligated service to April 2026 is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106. para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.

m. In accordance with reference (d) FY22 SRB Award Plan (N13 SRB 005/FY22), a Zone "B" SRB with an award level of 9.5 (\$100,000 award ceiling) for the ETN(SS)/N13O/S, rate/NEC was listed.

n. On 23 November 2022, Petitioner signed an agreement to extend enlistment for 15 months with a Soft EAOS of 19 January 2027 in order to incur sufficient obligated service to execute BUPERS order

o. On 23 November 2022, Petitioner transferred from and arrived to on 14 December 2022 for duty.

p. On 25 November 2022, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.

q. In July 2023, Petitioner was awarded NEC 805A.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an error warranting the following corrective action. The Board concluded that on 29 March 2022, Petitioner was issued official modification to orders with required obligated service to February 2026. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 28 April 2022, Petitioner entered Zone B. On 5 May 2022, Petitioner was issued official modification to BUPERS order: with required obligated service to April 2026. On 23 November 2022, Petitioner signed an agreement to extend enlistment for 15 months to meet the obligated service. The Board determined that Petitioner could have reenlisted upon entering Zone B in accordance with reference (b) and would have been eligible to reenlist for 5 years and receive a Zone B SRB on 21 October 2022.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 15-month agreement to extend enlistment (NAVPERS 1070/621) executed on 23 November 2022 is null and void.

Petitioner was discharged 20 October 2022 and reenlisted on 21 October 2022 for a term of 5 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "9.5" (\$100,000 award ceiling) for the ETN(SS)/N13S, rating/NEC. Remaining obligated service to 19 October 2025 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will not take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will not be funded by the BCNR's Claims Line of Accounting (LOA). at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive. Contact the , N133D,

concerning SRB payment.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
