- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted for 3 years and was eligible for and received a Zone B Selective Reenlistment Bonus (SRB) on 10 March 2023.
- 2. The Board, consisting of ______, _____, and _____ reviewed Petitioner's allegations of error and injustice on 19 November 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.
- 3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:
- a. On 9 March 2016, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 8 March 2020 and Soft EAOS of 8 March 2022; "[t]raining in the Nuclear Field. MILPERSMAN 1510-030 and MILPERSMAN 1306-500, 1306-502, and 1306-504 (NF) are governing directives. Advancement to Rate and Grade per MILPERSMAN 1430-010. I understand that this extension of active service becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN 1160-040 and 1510-030. In particular, I understand that when I accept advancement to E4, 12 months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training."
 - b. In March 2018, Petitioner was awarded Navy Enlisted Classification (NEC) N16O.

- d. On 16 June 2018, Petitioner reenlisted for 6 years with an EAOS of 15 June 2024 and received a Zone A SRB.
- e. In accordance with reference (b) announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required) except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.
- f. In accordance with reference (c) FY21 SRB Award Plan (N13SRB 005/FY21), a Zone "B" SRB with an award level of 7.0 (\$100,000 award ceiling) for the MMN(SS)/N16O/S, rate/NEC was listed.
- g. On 28 September 2021, Petitioner was issued official change duty orders (BUPERS order: 2711), with required obligated service to April 2025 with an effective date of departure of March 2022. Petitioner's ultimate activity was for duty with an effective date of arrival of 13 April 2022 with a projected rotation date of April 2025. Obligated service to April 2025, is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.
- h. On 9 December 2021, Petitioner signed an agreement to extend enlistment for 10 months with a Soft EAOS of 15 April 2025 in order to incur obligated service to execute BUPERS order 2711.
 - i. On 9 March 2022, Petitioner entered Zone B.
- j. On 11 March 2022, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.
- k. On 11 March 2022, Petitioner transferred from and arrived to on 12 April 2022 for duty.
- 1. In accordance with reference (d) FY23 SRB Award Plan (N13 SRB 001/FY23), a Zone "B" SRB with an award level of 8.5 (\$100,000 award ceiling) for the MMN(SS)/N16O/S, rate/NEC was listed.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an error warranting the following corrective action. The Board concluded that on 28 September 2021, Petitioner was issued orders 2711 with required obligated service to April 2025. At that time, a Zone B SRB was authorized in accordance with reference (c), however Petitioner was still in Zone A. On 9 December 2021, Petitioner signed an agreement to extend enlistment for 10 months to meet the obligated service. On 9 March 2022, Petitioner entered Zone B. The Board determined that Petitioner should have signed a NAVPERS

1070/613 vice extension of enlistment and would have been eligible to reenlist for 3 years and receive a Zone B SRB on 10 March 2023.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 10-month agreement to extend enlistment (NAVPERS 1070/621) executed on 9 December 2021 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 9 December 2021 agreeing to extend enlistment for 10 months for obligated service to April 2025.

Petitioner was discharged 9 March 2023 and reenlisted on 10 March 2023 for a term of 3 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "8.5" (\$100,000 award ceiling) for the MMN(SS)/N16O, rating/NEC. Remaining obligated service to 15 June 2024 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will <u>not</u> take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will <u>not</u> be funded by the BCNR's Claims Line of Accounting (LOA). _______ at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive. Contact the Assistant Nuclear Enlisted Program Manager, N133D, _______ concerning SRB payment.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
