	Board, having reviewed all the facts of record pertaining to Petitioner's allegations of nd injustice, finds as follows:
	Before applying to this Board, Petitioner exhausted all administrative remedies available existing law and regulations within the Department of the Navy.
	Although enclosure (1) was not filed in a timely manner, it is in the interest of justice to the application on its merits.
Petitio comple	Petitioner enlisted in the Marine Corps and began a period of active duty on 26 June 1984. ner was designated as a food service specialist (3181) on 26 September 1984. In 1987, he eted training, and was designated a Marine Security Guard (8151). In addition, his record is he served in both (1987), and (1988).

d. Upon his discharge, Petitioner was issued a Certificate of Release or Discharge from Active Duty (DD Form 214). Petitioner's DD Form 214 fails to annotate his service as a Marine

Security Guard (8151), and his overseas service.

e. Petitioner requests to change his Primary Specialty Number of 3381- Food Service to 8151- Marine Embassy Guard, and he would like to add his overseas service to his DD Form 214.

## CONCLUSION:

Upon review and consideration of the evidence of record and reference (b), the Board determined Petitioner's record warrants relief. As noted previously, Petitioner's DD Form 214 does not correctly indicate his MOS as a Marine Security Guard (8151) nor and his overseas service.

## RECOMMENDATION:

In view of the above, the Board directs the following corrective action:

That Headquarters, U.S. Marine Corps conduct a review of Petitioner's record to accurately document his overseas service.

That Petitioner be issued a Correction to DD Form 214, Certificate of Release or Discharge from Active Duty (DD Form 215), for the period ending on 25 September 1989, to add his foreign service in block 12f and add the Primary Specialty Number of "8151 - Marine Security Guard" in block 11.

That no further changes be made to Petitioner's record.

A copy of this report of proceedings be filed in Petitioner's naval record.
