- 1. Pursuant to the provisions of reference (a), Petitioner, a former member of the Navy, filed enclosure (1) requesting that errors be corrected on his DD Form 214. Enclosures (1) through (3) apply.
- 2. The Board, consisting of \_\_\_\_\_\_, \_\_\_\_, and \_\_\_\_\_, reviewed Petitioner's allegations of error and injustice on 10 June 2024, and pursuant to its regulations, determined that the corrective action indicated below should be taken. Documentary material considered by the Board consisted of Petitioner's application together with all material submitted in support thereof, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
- b. Although enclosure (1) was not filed in a timely manner, it is in the interest of justice to review the application on its merits.
  - c. Petitioner enlisted in the Navy and began a period of active service on 27 January 1953.
- d. On 12 December 1956, at the expiration of his term of active obligated service, and after having served honorably, Petitioner was transferred to the inactive reserves and issued a DD Form 214.

e. Petitioner contends his DD Form 214 contains two errors: (1) the year of his birth is incorrectly listed as "35" in block 6, instead of "36," and (2) his marital status is misspelled in block 9.

## CONCLUSION

Upon careful review and consideration of all of the evidence of record, the Board determined that Petitioner's request warrants relief.

The Board found sufficient evidence in the Petitioner's service record, specifically in his application for enlistment, to confirm his birth year of 1936. The Board also noted that the word "single" is misspelled in block 9 of Petitioner's DD Form 214.

## RECOMMENDATION

That Petitioner be issued a "Correction to DD Form 214, Certificate of Release or Discharge from Active Duty" (DD Form 215), for the period ending 12 December 1956, indicating the following changes:

Block 6: Year of birth to "36"

Block 9: Marital Status to "Single"

That no further changes be made to Petitioner's record.

That a copy of this report of proceedings be filed in Petitioner's naval record.

- 4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
- 5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulation, Section 723.6(e)) and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of reference (a), has been approved by the Board on behalf of the Secretary of the Navy.
