1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted for 4 years and was eligible for and received a Zone B Selective Reenlistment Bonus (SRB) on 23 December 2021.

2. The Board, consisting of **Sector 1** and **Sector 1** and **Sector 1** reviewed Petitioner's allegations of error and injustice on 3 December 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 9 June 2015, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 8 June 2019 and Soft EAOS of 8 June 2021; "[t]raining in the Nuclear Field MILPERSMAN 1510-030 and MILPERSMAN 1306-500, 1306-502, and 1306-504 (NF) are governing directives. Advancement to Rate and Grade per MILPERSMAN 1430-010. I understand that this extension of active service becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN 1160-040 and 1510-030. In particular, I understand that when I accept advancement to E4, 12 months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training."

b. In August 2017, Petitioner was awarded Navy Enlisted Classification (NEC) N16O.

c. On 27 September 2017, Petitioner transferred from and arrived at on 27 September 2017 for duty.

d. On 22 December 2017, Petitioner reenlisted for 6 years with an EAOS of 21 December 2023 and received a Zone A SRB.

e. In accordance with reference (b) announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required) except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.

f. In June 2021, Petitioner was awarded NEC N16S.

g. On 9 June 2021, Petitioner entered Zone B.

h. In accordance with reference (c) FY21 SRB Award Plan (N13SRB 005/FY21), a Zone "B" SRB with an award level of 7.0 (\$100,000 award ceiling) for the MMN(SS)/N16O/S, rate/NEC was listed.

i. On 18 August 2021, Petitioner was issued official change duty orders (BUPERS order: 2301), with required obligated service to May 2024, while stationed in

with an effective date of departure of November 2021. Petitioner's intermediate (01) activity was for temporary duty under instruction with an effective date of arrival of 8 November 2021. Petitioner's ultimate activity was for duty with an effective date of arrival of 29 April 2022 with a projected rotation date (PRD) of April 2025. Obligated service to May 2024, is required for this assignment which may be satisfied by reenlistment or extension of enlistment. Circumstances such as potential monetary loss under critical skills bonus or SRB, refer to MILPERSMAN 1306-106 para 4. Use of NAVPERS 1070/613 only authorized for SRB eligible sailors.

j. On 5 November 2021, Petitioner transferred from and arrived to on 9 November 2021 for temporary duty.

k. On 30 March 2022, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.

1. On 30 March 2022, Petitioner transferred from and arrived to and arrived to on 27 April 2022 for duty.

m. In May 2022, Petitioner was awarded NEC N76Z.

n. On 20 September 2022, Petitioner signed an agreement to extend enlistment for 16 months with a Soft EAOS of 21 April 2025 in order to match EAOS with PRD.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosures (2) and (3), the Board finds the existence of an error warranting the following corrective action. The Board concluded that on 9 June 2021, Petitioner entered Zone B. On 18 August 2021, Petitioner was issued orders 2301 with required obligated service to May 2024. At that time, a Zone B SRB was authorized in accordance with reference (c). On 20 September 2022, Petitioner signed an agreement to extend enlistment for 16 months to meet the obligated service. The Board determined that Petitioner should have signed a NAVPERS 1070/613 vice extension of enlistment and would have been eligible to reenlist for 4 years and receive a Zone B SRB on 23 December 2021.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 16-month agreement to extend enlistment (NAVPERS 1070/621) executed on 20 September 2022 is null and void.

Petitioner executed an Administrative Remarks (NAVPERS 1070/613) on 5 November 2021 agreeing to extend enlistment for 5 months for obligated service to May 2024.

Petitioner was discharged 22 December 2021 and reenlisted on 23 December 2021 for a term of 4 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "7.0" (\$100,000 award ceiling) for the MMN(SS)/N16S, rating/NEC. Remaining obligated service to 21 December 2023 will be deducted from SRB computation. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will <u>not</u> take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will<u>not</u> be funded by the BCNR's Claims Line of Accounting (LOA). at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive. Contact the Assistant Nuclear Enlisted Program Manager, N133D, **Concerning SRB** payment.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
