| 3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows: |  |
|   | On 2 April 2024, issued Petitioner a Company Invoice with a total \$4,069.52. Move date was 10 April 2024 with a requested deliver of 17 April 2024.   |

d. Petitioner was discharged with an honorable character of service and was issued a DD Form 214, Certificate of Release or Discharge from Active Duty for the period of 26 July 2017 to 17 May 2024 due to Disability, Severance Pay, Non-Combat Related IDES. Signed by authorized Official on 16 May 2024.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of reference (b) and enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that per reference (b), Household Goods (HHG) allowances are based on when orders are effective and certain criteria must be met in order to execute HHG transportation before an order is issued. The Board concluded that Petitioner was in the process of a medical discharge and was preparing for separation, therefore Petitioner had reason to believe that official separation orders would be forthcoming.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's official separation orders (BUPERS order: ) were issued on 1 April 2024 vice 26 April 2024.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
