1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 11 February 2021 for 4 years, was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).

2. The Board, consisting of ██████████, ██████████, and ██████████ reviewed Petitioner's allegations of error and injustice on 11 June 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 10 February 2015, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 9 February 2019 and Soft EAOS (SEAOS) of 9 February 2021; "Training in the Nuclear Field. MILPERSMAN 1510-030 and MILPERSMAN 1306-500, 1306-502, and 1306-504 (NF) are governing directives. Advancements Rate and Grade per MILPERSMAN 1430-010.1 understand that this extension of active service becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN 1160-040 and 1510-030. In particular, I understand that when I accept advancement to E4, 12

months of this agreement may not be cancelled whether or not I complete Nuclear Power or Advanced Training.”

- b. On 11 August 2016, Petitioner’s dependent child was born.
- c. On 23 November 2016, Petitioner got married.
- d. In January 2017, Petitioner was awarded Navy Enlisted Classification (NEC) N14O.
- e. On 6 March 2017, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 7 March 2017 for duty.
- f. On 20 June 2017, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 20 June 2017 for duty.
- g. In December 2017, Petitioner was awarded NEC 752B.
- h. On 4 May 2018 Petitioner reenlisted for 6 years with an EAOS of 3 May 2024 and received a Zone A SRB.
- i. In accordance with reference (b), this NAVADMIN announced revised SRB policy for Active Component and Full Time Support, superseding NAVADMIN 272/19. Sailors must now have reenlisted within 365 days of their EAOS (as opposed to 270 days required in NAVADMIN 272/19), except in the case of Nuclear-trained Sailors who could have reenlisted at any point in the reenlistment zone, per guidance in OPNAVINST 1160.8B.
- j. In accordance with reference (c), FY21 SRB Award Plan (N13SRB 002/FY21), a Zone “B” SRB with an award level of 7.0 (\$100,000 award ceiling) for the EMN(SS)/N14O/S, rate/NEC was listed.
- k. On 10 February 2021, Petitioner entered Zone B.
- l. On 17 March 2021, Petitioner was issued official change duty orders (BUPERS order: 0761), while stationed in [REDACTED], [REDACTED], [REDACTED] with an effective date of departure of July 2021. Petitioner’s ultimate activity was [REDACTED] [REDACTED], [REDACTED], [REDACTED] for duty with an effective date of arrival of 19 August 2021 with a Projected Rotation Date of August 2024.
- m. In April 2021, Petitioner awarded NEC N14S.
- n. On 11 May 2021, Petitioner signed an agreement to extend enlistment for 3 months with an SEAOS of 3 August 2024 in order to incur sufficient obligated service to execute BUPERS order 0761.
- o. On 14 July 2021, Petitioner transferred from [REDACTED], and arrived to [REDACTED] on 22 July 2021 for duty.

p. On 5 August 2021, Petitioner's Master Military Pay Account shows that Petitioner's Submarine Pay stopped.

q. On 7 June 2024, Petitioner's Benefits for Education Administrative Service Tool listed no dependents.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosures (2) and (3), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 10 February 2021, Petitioner entered Zone B. At that time, a Zone B SRB was authorized in accordance with reference (c). On 17 March 2021, Petitioner was issued BUPERS order: 0761 with no obligated service directed; however, the PRD is August 2024 and Petitioner's EAOS was 3 May 2024. On 11 May 2021, Petitioner signed an agreement to extend enlistment for 3 months to meet the OBLISERV. The Board determined that Petitioner should have been advised to reenlist after entering Zone B. On 11 February 2021, Petitioner would have been eligible to reenlist for 4 years and receive a Zone B SRB. Furthermore, Petitioner would have been eligible to transfer his education benefits to his dependents if he so chooses.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 3-month agreement to extend enlistment (NAVPERS 1070/621) executed on 11 May 2021 is null and void.

Petitioner was discharged 10 February 2021 and reenlisted on 11 February 2021 for a term of 4 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "7.0" (\$100,000 award ceiling) for the EMN(SS)/N14O, rating/NEC. Remaining obligated service to 3 May 2024 will be deducted from SRB computation. Additionally, Navy Personnel Command is authorized to align transfer of education benefits with the 11 February 2021 reenlistment upon Petitioner's request. Furthermore, that any other entries affected by the Board's recommendation be corrected.

The Board for Correction of Naval Records (BCNR) will not take any action with the Defense Finance and Accounting Service (DFAS) for the SRB payment. Petitioner's SRB payment will not be funded by the BCNR's Claims Line of Accounting (LOA). LT [REDACTED] at N133D has secured funding via unexecuted SRB funds and will use their LOA to pay the SRB payment, and will coordinate directly with the DFAS to determine Petitioner's incentive. Contact the Assistant Nuclear Enlisted Program Manager, N133D, LT [REDACTED], [REDACTED], [REDACTED] concerning SRB payment.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
