- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to reflect cancelled participation in the 2023 Survivor Benefit Plan (SBP) Open Season Enrollment.
- 2. The Board, consisting of ______, and _____ reviewed Petitioner's allegations of error and injustice on 16 October 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:
- a. In accordance with reference (b), there are no regular recurring open season periods. Open seasons must be specifically prescribed by law. The most recent SBP open season, which was authorized by reference (b), began 23 December 2022, and ended 1 January 2024, allowing eligible members to participate or discontinue participation. The SBP Open Season allows for eligible members who, on 22 December 2022, are not currently in SBP or Reserve Component SBP to enroll. For a member who enrolls during the SBP Open Season, the law generally requires that the member will be responsible to pay retroactive SBP premium costs that would have been paid if the member had enrolled at retirement (or enrolled at another earlier date, depending on the member's family circumstances). Reference (c) specified members who elected to participate in an open enrollment had the ability to cancel within 30 days of making the election.

- b. On 12 November 1993, Petitioner married
- c. On 25 May 2000, Petitioner signed DD Form 2656, Data for Payment of Retired Personnel and elected not to participate in SBP with spouse concurrence.
 - d. Petitioner transferred to Fleet Reserve effective 1 November 2000.
- e. On 12 December 2023, Petitioner signed SBP and Reserve Component SBP Open Enrollment Election. Petitioner elected for Spouse only coverage based on the full gross pay level of coverage and selected Enrollment Premium Option a. ("Based on the estimate I received, I elect to submit a one-time full payment for the total amount of the "buy-in premium" due."). Petitioner's SBP Spouse only premium deductions began effective 14 December 2023.
- f. On 24 January 2024, Petitioner wrote the Defense Finance and Accounting Service (DFAS) requesting to withdraw SBP enrollment.
- g. On 30 January 2024, the DFAS confirmed receipt of Petitioner's 2023 SBP Open Season enrollment and issued Petitioner SBP Open Season 2023 Enrollment Confirmation. The enrollment data within the confirmation included a prospective monthly premium of \$139.36 and one-time "buy-in premium" estimate of \$45,259.95.
- h. On 5 June 2024, the DFAS denied Petitioner's request to cancel Open Season enrollment due to not receiving cancellation notice within 30 days of signature of the enrollment form.

CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an error warranting the following corrective action. The Board determined there is no record of Petitioner submitting a Letter of Intent to Enroll During the SBP Open Season that would have prompted the DFAS to provide Petitioner with the Individual 2023 SBP Open Enrollment Estimate prior to him submitting his application to enroll in SBP Spouse coverage. The Board surmised that Petitioner's election was during the holidays and toward the end of the authorized period to enroll during the 2023 SBP Open Season Enrollment, resulting in his enrollment without being aware of the cost until after the deadline to cancel enrollment. Although Petitioner did not complete the proper administrative requirements, the Board determined that under this circumstance, relief is warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner elected to cancel his 2023 SBP Open Season Enrollment within 30 days of making the election.

The DFAS will complete an audit of Petitioner's pay records to determine amounts due, if any.
