1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his period of active duty service be corrected on a Certificate of Release or Discharge from Active Duty (DD Form 214).

2. The Board, consisting of ██████████, ██████████, and ██████████, reviewed Petitioner's allegations of error and injustice on 7 August 2024 and, pursuant to its regulations, determined that the corrective action indicated below should be taken. Documentary material considered by the Board consisted of Petitioner's application together with all material submitted in support thereof, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. Although enclosure (1) was not filed in a timely manner, it is in the interest of justice to review the application on its merits.

c. On 2 August 1952, Petitioner enlisted in the Navy Reserve. On 4 June 1954, he was ordered to active duty training to attend a 90-day Aviation Electronic Training Program. On 19 June 1954, he reported to active duty training. On 15 September 1954, he completed the training and was subsequently reassigned to the Inactive Navy Reserve on 16 September 1954.

e. At the time of his release from active duty training, Petitioner did not received a DD Form 214 that documents his period of active duty service from 19 June 1954 to 16 September 1954.

f. On 17 June 1964, Petitioner was discharged from the Navy Reserve with an Honorable Discharge.

CONCLUSION:

Upon review and consideration of all the evidence of record, the Board concluded Petitioner's request merits relief. As discussed, Petitioner was not issued a DD Form 214 to document his period of active duty service for training from 19 June 1954 to 16 September 1954.

RECOMMENDATION:

In view of the foregoing, the Board finds the existence of an injustice warranting the following corrective action:

That Petitioner be issued a new "Certificate of Release or Discharge from Active Duty" (DD Form 214) documenting his Honorable period of active duty for training from 19 June 1954 to 16 September 1954.

That no further changes be made to Petitioner's record.

That a copy of this report of proceedings be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of reference (a), has been approved by the Board on behalf of the Secretary of the Navy.
