1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to reflect declined participation in the Survivor Benefit Plan (SBP).

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 5 November 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, she exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:

a. On 23 May 2008, Petitioner married [REDACTED] and divorced on 26 December 2014. Judgement for Dissolution did not order SBP Former Spouse coverage.

b. On 19 May 2017, Petitioner married [REDACTED].

c. On 12 February 2024, Petitioner signed DD Form 2656, Data for Payment of Retired Personnel and elected not to participate in SBP; however, witness to Petitioner's signature signed the form on 14 February 2024. Petitioner's spouse signed the form on 13 February 2024 before a notary witness.

d. On 14 February 2024, Petitioner signed DD Form 2656, Data for Payment of Retired Personnel before a witness and elected not to participate in SBP. Petitioner's spouse signed the form on 24 February 2024; however, the notary witness signature was dated 13 February 2024.

e. Petitioner transferred to the Retired List effective 1 June 2024 and automatically enrolled in SBP Spouse coverage as a result of the invalid entries on his DD Form 2656, Data for Payment of Retired Personnel.

f. On 15 October 2024, Petitioner and spouse signed SBP Affidavit before a notary witness requesting to decline SBP coverage.

CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an error warranting the following corrective action. The Board concluded Petitioner provided sufficient evidence to reflect his and spouse's desire to decline SBP coverage prior to transferring to the Retired List. Although the proper administrative requirements were not completed, the Board determined that under this circumstance, relief is warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner elected to decline participation in SBP with proper spousal concurrence prior to transferring to the Retired List effective 1 June 2024.

Note: The Defense Finance and Accounting Service will complete an audit of Petitioner's pay records to determine amounts due, if any.

A copy of this report of proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above titled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
