This is in reference to your application for correction of your naval record pursuant to Section 1552 of Title 10, United States Code. After careful and conscientious consideration of relevant portions of your naval record and your application, the Board for Correction of Naval Records (Board) found the evidence submitted insufficient to establish the existence of probable material error or injustice. Consequently, your application has been denied.

A three-member panel of the Board, sitting in executive session, considered your application on 3 December 2024. The names and votes of the members of the panel will be furnished upon request. Your allegations of error and injustice were reviewed in accordance with administrative regulations and procedures applicable to the proceedings of this Board. Documentary material considered by the Board consisted of your application, together with all material submitted in support thereof, relevant portions of your naval record and applicable statutes, regulations, and policies.

You requested that the Board reconsider reopen the Line of Accounting (LOA) for your Personally Procured Move which expired. The Board, in its review of your entire record and application, carefully weighed all potentially mitigating factors, to include your assertions. You stated that you misplaced your file after it was denied and only recently found it. You also stated that you request reconsideration due to unexpected life issues using all your leave to care for your terminally ill father who you lost only a month after moving to your new command. However, the Board concluded that in accordance with Transportation of Personal Property Naval Supply Systems Command Publication 490, REV 6, Navy Permanent Change of Station funding is only good for the fiscal year (FY) issued plus five additional FYs. Requests for additional funding must be sent via email with justification to the Naval Supply Systems Command Household Goods Policy Team. Your orders were issued in FY18, and the LOA was valid through FY23. You initially submitted your claim on 9 April 2018, and you were informed that additional information was required, however, you did not respond, and the LOA expired. The Board sympathized that you were supporting your father during his illness, however there is no evidence that you contacted Naval Supply Systems Command in the 6 years that followed to ask if they retained your previous file or for any other assistance. Therefore, the Board determined that a change to your record is not warranted.

You are entitled to have the Board reconsider its decision upon submission of new matters, which will require you to complete and submit a new DD Form 149. New matters are those not previously presented to or considered by the Board. In this regard, it is important to keep in mind that a presumption of regularity attaches to all official records. Consequently, when applying for a correction of an official naval record, the burden is on the applicant to demonstrate the existence of probable material error or injustice.
