1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show that Petitioner's total active-duty service is 28 years, 11 months, and 13 days vice 28 years, 7 months and 18 days for retirement pay calculation.

2. The Board, consisting of ██████████, ██████████, and ██████████ reviewed Petitioner's allegations of error and injustice on 6 February 2025 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. Reference (b) BUPERSINST 1001.39F CH-1, published on 3 May 2013, Retirement Point Credit by Activity.

Active Service. One Point for each day of active service. Active service is service on Active Duty including Annual Training, Active-Duty Training (ADT), Initial Active Duty for Training and Active Duty for Special Work.

Inactive Duty Service. Inactive duty service will be credited as follows: a. One point for each attendance at a regularly scheduled or rescheduled Inactive Duty Training (IDT) period (drill), Additional Training Period, Additional Flying Training Period, or Readiness Management Period. See chapter 12 for definitions of IDTs. b. A maximum of two retirement points may be

credited for attendance at IDT periods in any 1 calendar day. c. One point per 3 hours of authorized non-resident instruction successfully completed. The number of retirement points authorized for Navy non-resident correspondence courses is listed for each course.

b. Reference (d) the active-duty service date (ADSD) is the actual or adjusted date from which the amount of active military service performed is calculated. The ADSD reflects all periods of active federal military service in commissioned officer, warrant officer, or enlisted status.

c. Petitioner was separated with an honorable character of service and was issued a Department of the Army and the Air Force National Guard Bureau, Report of Separation and Record of Service (NGB Form 22) - Report of Separation and Record of Service in the Army National Guard of [REDACTED] effective 14 January 1995 with a total service for pay 2 years, 8 months, and 7 days. Furthermore, block 18 (Remarks) listed the following: "...Date last appointed in the ARNG: 920513. Individual's military status during the period of 90906-920507 while participating in MS III and MS IV Phases of ROTC was not creditable for retirement purposes, longevity, accrual of retirement points, nor completion of a Reserve obligation. ADT Period: 920823-921215; DD Form 214 issued."

d. On 10 March 1995, Department of the Army and the Air Force National Guard Bureau Correction to NGB Form 22 was issued correcting items 8b (Effective date) 950112 and 10d (Total service for pay) 020805.

e. Petitioner was released from active duty with an honorable character of service and was issued a Certificate of Release or Discharge from Active Duty (DD Form 214) for the period of 13 January 1995 to 31 March 1999 for Intradepartmental Transfer.

f. On 11 February 1999, Petitioner was issued an Officer Appointment Acceptance and Oath of Office (NAVPERS 1000/4) with a designator code of 1395 (An Unrestricted Line Officer who is in training for duty involving flying as a pilot) in the active U.S. Navy Reserve listing block 13 (Permanent grade) LT, block 14 (Permanent grade date) 1 June 1997, block 15 (Present Grade) LT, and block 16 (Present grade date) 1 June 1997. Petitioner/witness signed this form on 1 April 1999.

g. Petitioner retired with an honorable character of service and was issued a Certificate of Release or Discharge from Active Duty (DD Form 214) for the period of 1 April 1999 to 31 August 2023 for maximum service or time in grade.

h. On 15 September 2023, the Defense Finance and Accounting Service (DFAS) notified Petitioner that "[w]elcome to the Retired roll of the United States Navy. Based on official information received at this Center, we have initiated your retired pay account as shown on the enclosed summary. However, all documents necessary to ensure accurate establishment of your account have not been received. As soon as these documents are obtained, your account will be systematically reviewed and adjusted for any underpayments or overpayments.

Your regular monthly net pay will be processed by the first of the month and will be transmitted to your payment address.” Furthermore, the DFAS provided a Summary of Retired Pay Account with the following information: Date of Retirement 1 September 2023, Service for Basic Pay 31 years, 3 months, 23 days, and Service for Percent: 28 years, 7 months, 18 days.

i. Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (ESR) shows Member Data Summary lists a Pay Entry Base Date of 8 May 1992 and ADSD 13 January 1995.

j. The DFAS HUNT system shows Petitioner’s service entry date is 8 May 1992, his retirement date is 1 September 2023 and Pay Entry Base Date is 8 May 1992. Service base pay is 31 years, 3 months, and 23 days, service percent multiplier is 28 years, 7 months, and 18 days, and Total Active Service is 28 years, 7 months, and 18 days.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following partial corrective action. The Board agreed that Petitioner completed a period of ADT from 23 August 1992 through 15 December 1992, however Petitioner’s total active-duty service currently reflected in the DFAS Hunt system and NSIPS/ESR does not include this ADT period. The Board determined that Petitioner is entitled to have his active-duty service corrected, however because the Board does not calculate retired pay, Petitioner’s account will need to be audited by the DFAS, and his retired pay will be calculated with the additional active-duty period.

## RECOMMENDATION

That Petitioner’s naval record be corrected, where appropriate, to show that:

Petitioner completed a period of ADT from 23 August 1992 to 15 December 1992.

Note: This change will entitle Petitioner to additional active service and an increase to his retirement percent multiplier/retire pay. Furthermore, NPC will complete an audit of Petitioner’s active-duty service date and adjust accordingly and that any other entries affected by the Board’s recommendation be corrected. Additionally, the DFAS will complete an audit of Petitioner’s records to determine amounts due, if any.

That a copy of this report of proceedings be filed in Petitioner’s naval record.

That no further changes be made to Petitioner’s naval record.

4. It is certified that a quorum was present at the Board’s review and deliberations, and that the foregoing is a true and complete record of the Board’s proceedings in the above titled matter.
