3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

a. In accordance with reference (b) NAVSO P-6034, Joint Travel Regulations (JTR), the home of record (HOR) and or place from which called or ordered to active duty (PLEAD) are used to determine a member's entitlement to travel and transportation allowances or other compensations provided by law. To support these entitlements, these places will be documented (as prescribed below) and must not be changed, except as authorized.

PLEAD. The place of acceptance in current enlistment, commission, or appointment of an active Service member, or of a member of the Reserve Component (RC) when enlisted, commissioned, or appointed for immediate active duty.

For an inductee, it is the location of the local Selective Service Board to which the individual first reported for delivery to the induction station.

Subj: REVIEW OF NAVAL RECORD ICO XXXX-XX-
Effective 1 January 1983: In the case of a non-prior service midshipman or cadet at a Service academy, or a civilian college or university, the place where the member attains a military status or where the member enters the Service. Generally, this is the academic institution and not the member's HOR (reference (b)).
In the case of an RC member who is not enlisted, commissioned, or appointed for immediate active duty, the place to which an order to active duty is addressed.
Where to record the PLEAD: (1) The initial PLEAD for officers must be recorded on NAVPERS 1070/74. (2) The initial PLEAD for enlisted members must be recorded on DD 4. (3) The PLEAD for a reservist ordered to active duty will be recorded on the member's orders to active duty and in the ESR.
Note: The PLEAD changes only if there is a break in service exceeding 1 full day, in which case it is the place of entry into the new period of service.
b. On 2 February 2024, Petitioner was issued Official Recall to Active-Duty Mobilization Orders at the following address: Furthermore, to report to with a no later than 08:00 on 31 May 2024. Petitioner's
ultimate activity was 23461-5200 for duty with an effective date of arrival of 29 June 2024 and a current period of 28 days and 251 BOG. Furthermore, "[a]ll address changes in NSIPS will require an order modification; failure to do so may result in erroneous pay and entitlements while the member is activated."
c. Petitioner was released from active duty and transferred to the Navy Reserve with an Honorable character of service and was issued a Certificate of Release or Discharge from Active Duty (DD Form 214) for the period of 23 October 2020 to 23 April 2024 upon completion of required active service. Furthermore, block 19a (Mailing address after separation) listed. Finally, Official certified on 9 April 2024.
d. On 23 April 2024, Navy Standard Integrated Personnel System (NSIPS) listed Petitioner's address is
e. On 8 August 2024, NAVSUP Fleet Logistics Center Norfolk notified BCNR that "[t]here is nothing in PPTAS [Personal Property Transportation Auditing System] or DPS [Defense Personal Property System] showing a 2024 HHG [Household Goods] move."
CONCLUSION
Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an error warranting the following corrective action. The Board concluded that on 2 February 2024, Petitioner received Official Recall to Active-Duty Mobilization Orders at the following address: no later than 0800 on 31 May 2024. On 23 April 2024, Petitioner updated his address in NSIPS to

accordance with reference (b), the PLEAD for a reservist ordered to active duty will be recorded on the member's orders to active duty and in the ESR. Additionally, the orders state that all address changes in NSIPS will require an order modification. The Board determined that Petitioner updated his address in NSIPS prior to execution and with enough time for a modification to be issued, however his orders were not modified accordingly, resulting in overpayment of BAH.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:
