



- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to cancel operative/non-operative extension and show that Petitioner reenlisted on 6 January 2021 for 4 years, was eligible for and received a Zone B Selective Reenlistment Bonus (SRB).
- 2. The Board, consisting of _____, and ____ reviewed Petitioner's allegations of error and injustice on 15 October 2024 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.
- 3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:
- a. On 5 January 2015, Petitioner entered active duty for 4 years with an End of Active Obligated Service (EAOS) of 4 January 2019 and Soft EAOS of 4 January 2021; "[t]raining in the Nuclear Field. MILPERSMAN 1510-030 and MILPERSMAN 1306-500, 1306-502, and 1306-504 (NF) are governing directives. Advancement to Rate and Grade per MILPERSMAN 1430-010. I understand that this extension of active service becomes binding upon execution, and thereafter may not be cancelled, except as set forth in MILPERSMAN 1160-040 and 1510-030. In particular, I understand that when I accept advancement to E4, 12 months of this





- q. On 4 March 2024, Petitioner signed an agreement to extend enlistment for 6 months with a Soft EAOS of 28 January 2025 in order to obligate service.
- r. On 9 October 2024, Petitioner's Benefits for Education Administrative Service Tool listed no dependents.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an error warranting the following corrective action. The Board concluded that on 5 January 2021, Petitioner entered Zone B. On 1 June 2021, NSIPS/ESR shows an 8-month agreement to extend enlistment to meet the obligated service. On 14 June 2021, Petitioner was issued BUPERS order: with required obligated service to July 2024. At that time, a Zone B SRB was authorized in accordance with reference (c). The Board determined that Petitioner could have reenlisted upon entering Zone B in accordance with reference (b) and would have been eligible to reenlist for 4 years and receive a Zone B SRB on 6 January 2021. Furthermore, Petitioner would have been eligible to transfer his education benefits to his dependents if he so chooses.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 8-month agreement to extend enlistment (NAVPERS 1070/621) operative on 29 November 2023 is null and void.

Petitioner's 6-month agreement to extend enlistment (NAVPERS 1070/621) executed on 4 March 2024 is null and void.

Petitioner was discharged 5 January 2021 and reenlisted on 6 January 2021 for a term of 4 years.

Note: This change will entitle Petitioner to a Zone "B" SRB with an award level of "7.5" (\$100,000 award ceiling) for the EMN(SW)/N24S, rating/NEC. Remaining obligated service to 28 November 2023 will be deducted from SRB computation. Additionally, Navy Personnel Command is authorized to align transfer of education benefits with the 6 January 2021 reenlistment upon Petitioner's request. Furthermore, that any other entries affected by the Board's recommendation be corrected.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
