Dear ,

This is in reference to your application for correction of your naval record pursuant to Section 1552 of Title 10, United States Code. After careful and conscientious consideration of relevant portions of your naval record and your application, the Board for Correction of Naval Records (Board) found the evidence submitted insufficient to establish the existence of probable material error or injustice. Consequently, your application has been denied.

Although your application was not filed in a timely manner, the Board found it in the interest of justice to waive the statute of limitations and consider your case on its merits. A three-member panel of the Board, sitting in executive session, considered your application on 20 March 2025. The names and votes of the members of the panel will be furnished upon request. Your allegations of error and injustice were reviewed in accordance with administrative regulations and procedures applicable to the proceedings of this Board. Documentary material considered by the Board consisted of your application, together with all material submitted in support thereof, relevant portions of your naval record and applicable statutes, regulations, and policies.


On 30 July 1984, you enlisted in the U.S Marine Corps Reserve for 8 years with an Expiration of Obligated Service of 29 July 1992.

Your Military and Civilian Occupational Specialties, Schools, Tests, and Correspondence Courses (NAVMC 118 (8A) lists under "Military Occupational Specialties" that on 19 December 1985, you were assigned Primary MOS 0151.

You were transferred to Marine Corps Reserve with an honorable character of service and were issued a Certificate of Release or Discharge from Active Duty (DD Form 214) for the period of 1 July 1985 to 3 May 1989 upon completion of required active service (Return from overseas with less than 90-days to EAS). Furthermore, block 11 (Primary specialty number, title, and years and months in specialty) lists 0151 Administrative Clerk (3 years, 4 months).

Your Military and Civilian Occupational Specialties, Schools, Tests, and Correspondence Courses (NAVMC 118 (8A) lists under "Military Occupational Specialties" that on 8 May 1991, you were assigned Primary MOS 2111.

In accordance with Military Occupational Specialties Manual published in 1992, "MOS 0231, Intelligence Specialist (MSgt to Pvt). Summary. Intelligence specialists have a basic familiarity



with all phases and facets of intelligence with emphasis on tactical intelligence. Typical duties of intelligence specialists are assisting in collecting, recording, evaluating, interpreting, and disseminating intelligence. Intelligence specialists may manage the administration of intelligence sections up to and including a HEB. IDS 0231 may be assigned as a secondary MJS to other intelligence personnel upon completion of basic and intermediate schools. All personnel must possess the appropriate security clearance."

On 30 September 1994, you were discharged.

In accordance with Marine Corps Separation and Retirement Manual (MCO P1900.16) published on 18 August 1995, "11. PRIMARY SPECIALTY NUMBER (List number, title, and years and months in specialty. List additional specialty numbers and titles involving periods of one or more years.). Enter the Marine's military occupational specialty (MOS) followed by the English description and the number of years and months the Marine held the MOS, e.g., "0131, Unit Diary Clerk, 3 years 11 months". If the Marine is assigned an additional MOS and has held the additional MOS for 1 year or more, the additional MOS information will be entered below the primary MOS data."

On 18 October 1996, The Army Institute for Professional Development issued you a certificate of completion for successfully completing Counterintelligence Special Agent Course (MOS 978).


On 31 December 1996, you reenlisted in the U.S. Marine Corps Reserve for 4 years with an end of current contract of 30 December 2000.

On 15 March 1999, your Reporting Senior signed your TD USMC Fitness Report (NAVMC 10835A) for the period of 18 October 1998 to 31 March 1999 while you were a Counter-Drug Intelligence Analyst. Furthermore, block 1g (PMOS) listed 2111 and block 1h (BILMOS) listed 0231.

On 24 April 1999, Multijurisdictional Counterdrug Task Force Training, issued you a certificate of completion for successfully completing Advanced Analytical Investigative Techniques.

On 24 September 1999, your Reporting Senior signed your TD USMC Fitness Report (NAVMC 10835A) for the period of 17 April 1999 to 24 September 1999 while you were an Intelligence Analyst. Furthermore, block 1g (PMOS) listed 0151 and block 1h (BILMOS) listed 0231.

You were released from active duty with an honorable character of service and were issued a DD Form 214 for the period of 17 April 1999 to 24 September 1999 upon completion of required active service. Furthermore, block 11 (Primary specialty) listed 0151 Administrative Clerk (5 months).



On 31 March 2000, your Reporting Senior signed your FD USMC Fitness Report (NAVMC 10835A) for the period of 17 October 1999 to 31 March 2000 while you were an Intelligence Analyst. Furthermore, block 1g (PMOS) listed 2111 and block 1h (BILMOS) listed 0231.

You were released from active duty with an honorable character of service and were issued a DD Form 214 for the period of 16 October 1999 to 30 March 2000 upon completion of required active service. Furthermore, block 11 (Primary specialty) listed 0151 Administrative Clerk (5 months).

On 5 September 2000, your Reporting Senior signed your FD USMC Fitness Report (NAVMC 10835A) for the period of 17 April 2000 to 5 September 2000 while you were an Intelligence Analyst. Furthermore, block 1g (PMOS) listed 2111 and block 1h (BILMOS) listed 0231.

You were released from active duty with an honorable character of service and were issued a DD Form 214 for the period of 16 April 2000 to 22 September 2000 upon completion of required active service. Furthermore, block 11 (Primary specialty) listed 0151 Administrative Clerk (5 months).

On 3 January 2001, you signed an agreement to extend enlistment for 3 months with an end of current contract of 30 March 2001 upon having sufficient obligated service to complete reenlistment request.

You requested to add the MOS of 0231 to your DD Form 214 with the Date of Separation of 22 September 2000, the Board in its review of your entire record and application, carefully weighed all potentially mitigating factors, to include your assertions. You assert that your DD Form 214 only lists the MOS 0151-Administration Clerk, however you were working in an 0231 billet- Intelligence Specialist. However, the Board concluded that in accordance with Marine Corps Order 1200.17, "This MOS will be assigned and voided only by the CMC (MM)." The Board agreed that although several of your NAVMC 10835As listed a Billet MOS of 0231, the Board found no evidence that you were ever assigned MOS 0231 by Headquarters, U.S. Marine Corps. Therefore, the Board determined that a change to your record is not warranted.

You are entitled to have the Board reconsider its decision upon submission of new matters, which will require you to complete and submit a new DD Form 149. New matters are those not previously presented to or considered by the Board. In this regard, it is important to keep in mind that a presumption of regularity attaches to all official records. Consequently, when applying for a correction of an official naval record, the burden is on the applicant to demonstrate the existence of probable material error or injustice.
