- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that her naval record be corrected to show that Petitioner declined participation in Survivor Benefit Plan (SBP).
- 2. The Board, consisting of ______, ______, and ______ reviewed Petitioner's allegations of error and injustice on 19 March 2025 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.
- 3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:
- a. On 24 August 2011, Petitioner's first dependent child was born. On 7 July 2016, Petitioner got married and gained two stepchildren. On 12 May 2019, Petitioner's fourth dependent child was born.
- b. In accordance with reference (b), Election Coverage. 4.1.1. A member may elect coverage at the maximum level or at a reduced amount with spouse's concurrence, if required, for: 4.1.1.1. An eligible spouse only; 4.1.1.2. An eligible spouse and dependent child(ren); or 4.1.1.3. Dependent child(ren) only. 4.1.2. Every retiring member who is married at retirement is automatically enrolled in SBP for full coverage unless the spouse consents in writing to reduced coverage or no coverage before the first day of eligibility to receive retired pay. See subparagraph 4.1.4.

Spousal Concurrence. Written spousal concurrence is required when the member elects to decline coverage or provide the spouse with less than the maximum SBP coverage available,

include electing child-only coverage, and when a member eligible for RCSBP declines coverage or elects coverage that provides less than a maximum immediate spouse annuity. The signature of the spouse must be notarized. The requirement to have the spouse's signature notarized is not to suggest that the spouse has received additional counseling regarding the option being selected. It simply provides certification that the spouse signed the form and acknowledges the election made on the form. 5.3.5.1. If all requirements for an election needing the spouse's concurrence have not been satisfied prior to retirement, full spouse costs and coverage will be implemented, regardless of any request by the member to do otherwise. In such cases, when the member has requested any form of child coverage, full spouse and child coverage will be implemented. Any change in SBP election subsequent to retirement will be done through an administrative correction of records as permitted by law.

Once participation is discontinued under this provision, no benefits may be paid in conjunction with the member's previous participation. No refund of any premiums properly collected will be made. 7.1.8. A member who discontinues SBP participation pursuant to this paragraph may not later resume coverage or elect SBP coverage upon acquisition of another class of beneficiary.

- c. On 1 December 2023, Petitioner's spouse/witness signed Petitioner's Data for Payment of Retired Personnel (DD Form 2656) block 36g (SBP beneficiary categories) certifying "I elect not to participate in SBP." Furthermore, Petitioner failed to sign and date the form.
- d. Petitioner retired with an honorable character of service and was issued a DD Form 214, Certificate of Release or Discharge from Active Duty for the period of 26 January 1999 to 31 May 2024 upon having sufficient service for retirement.
- e. On 19 September 2024, Defense Finance and Accounting Service (DFAS) notified The Honorable United States Representative that "[t]his is in reply to your inquiry on behalf of Lieutenant Commander (LCDR) [Petitioner], U.S. Navy (Ret). Your inquiry pertains to [Petitioner's] Survivor Benefit Plan (SBP) account.

The SBP was enacted to allow retired members of the Uniformed Services an opportunity to provide a portion of their retirement pay to their surviving beneficiaries.

[Petitioner] retired, effective June 1, 2024.

We establish automatic SBP coverage on all retired pay accounts when we do not receive a valid Data for Payment of Retired Personnel (DD Form 2656) to process the SBP, or if there is no form at all.

The law states that every retiree who is married or has children at the time of retirement is automatically enrolled in SBP at the maximum rate, unless the retiree elected otherwise before retirement, or if the DD Form 2656 is invalid.

We set [Petitioner's] SBP coverage to automatic (Spouse) coverage effective the same date as her retirement because her DD Form 2656 was not signed and dated by her."

- f. On 15 November 2024, Petitioner and spouse signed and notarized a Survivor Benefit Plan (SBP) Affidavit declining SBP coverage.
- g. On 12 December 2024, DFAS HUNT system listed SBP coverage for spouse only in the amount of \$373.84.

CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an error warranting the following corrective action. The Board concluded that Petitioner's spouse and Notary signed the DD Form 2656 declining SBP on 1 December 2023, however Petitioner's signature and the witness signature were missing. As a result, DFAS auto enrolled Petitioner in SBP spouse coverage. The Board agreed that Petitioner provided sufficient evidence to reflect her and spouse's desire to decline SBP coverage prior to her retirement. Although Petitioner did not complete the proper administrative requirements, the Board determined that under these circumstances, relief is warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner elected to decline participation in SBP with spouse concurrence prior to transferring to the Retired List with pay effective 1 June 2024.

Note: The DFAS will complete an audit of Petitioner's pay records to determine amounts due, if any.

A copy of this report of proceedings will be filed in Petitioner's naval record.

- 4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above titled matter.
- 5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
