1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting his record be corrected to change the date of birth listed on his discharge documents.

2. The Board consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 13 December 2024 and, pursuant to its regulations, determined that the corrective action indicated below should be taken. Documentary material considered by the Board consisted of Petitioner's application together with all material submitted in support thereof, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies..

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. Although the enclosure was not filed in a timely manner, it is in the interest of justice to review the application on its merits.

c. The Petitioner enlisted in the Marine Corps and completed a period of honorable service from 23 June 1958 to 21 June 1960.

d. At the time of Petitioner's discharge, he was issued a Armed Forces of the United States Armed Forces of the United States Report of Transfer or Discharge (DD Form 214). Petitioner's DD Form 214 erroneously reflects his date of birth (DOB) as "[REDACTED]"

e. Petitioner requests correction of the DOB listed on his DD Form 214 from "[REDACTED]" to "[REDACTED]" Petitioner provides a copy of his Illinois Driver's License reflecting his DOB as "[REDACTED]"

CONCLUSION:

Upon review and consideration of all the evidence of record, the Board concludes there is an error in Petitioner's record, therefore, his request for correction warrants favorable action. The Board notes Petitioner provides sufficient evidence to reflect his DD Form 214 incorrectly reflects his DOB as "[REDACTED]" In this regard, Petitioner's DOB should reflect "[REDACTED]"

In view of the above, the Board directs the following corrective action.

RECOMMENDATION:

That Petitioner be issued a Correction to DD Form 214, Armed Forces of the United States Report of Transfer or Discharge (DD Form 215) which reflects correction of Petitioner's DOB from "[REDACTED]" to "[REDACTED]"

That a copy of this Report of Proceedings be filed in Petitioner's Naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
