Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show that he reenlisted in the U.S. Navy (USN) status vice U.S. Navy Reserve (USNR).
- 2. The Board, consisting of \_\_\_\_\_, and \_\_\_\_ reviewed Petitioner's allegations of error and injustice on 7 January 2025, and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations and policies.
- 3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:
- a. On 6 August 2018, Petitioner enlisted in the U.S. Naval Reserve for 8 years with an expiration of obligated service of 5 August 2026. On 17 September 2018, Petitioner entered active duty in the U.S. Navy for 4 years with an End of Active Obligated Service (EAOS) of 16 September 2022.
- b. On 9 July 2022, Petitioner erroneously reenlisted for 4 years with an EAOS of 8 July 2026 in the U.S. Naval Reserve (Branch class 32 Full Time Support) vice U.S. Navy (Branch class 11). Petitioner's immediate reenlistment contract (NAVPERS 1070/601) listed the following: BR/CL: USNR, Status: Active, and RADO (Reserve Active-Duty Obligation) months/days of 000/000.

c. On 16 August 2024, Commanding Officer, Navy Information Operations Command notified Officer in Charge, Records Support Division (PERS-313) via Officer in Charge, Transaction Service Center Naval Base that "[r]equest the immediate reenlistment contract (NAVPERS 1070/601) in case of [Petitioner], dated 9 July 2022, be deleted and replaced with the enclosed NAVPERS 1070/601. Due to administrative error, the branch/class was entered incorrectly."

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an error warranting the following corrective action. The Board concluded that on 9 July 2022, Petitioner reenlisted for 4 years in the U.S. Naval Reserve (Branch class 32 - Full Time Support), however Petitioner is a USN (Branch/Class 11) Sailor. Therefore, his reenlistment contract should list BR/CL: USN vice USNR. Furthermore, Petitioner provided a second 4-year immediate reenlistment contract (NAVPERS 1070/601) executed on 9 July 2022, that is not filed in his naval record, listing the following: BR/CL: USN vice USNR.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 4-year immediate reenlistment contract (NAVPERS 1070/601) executed on 9 July 2022 listed the following: BR/CL: USN vice USNR. Note: Any other entries affected by the Board's recommendation be corrected.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.
