The Board consisting of petitioner's allegations of error and injustice on 3 March 2025 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. | 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows: |
| a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. Although Petitioner die not file her application in a timely manner, the statute of limitation was waived in accordance with the Kurta Memo. |
| b. Petitioner is service member's (SM's) daughter. SM enlisted in the Navy and began a period of active duty on 14 September 1951. |
| c. On 8 July 1953, SM was honorably discharged from active duty. At the time of his service, SM indicated his date of birth as |
