1. Pursuant to the provisions of reference (a), Petitioner, a former member of the Naval Reserve, filed enclosure (1) requesting the separation authority in block 25 of his DD Form 214 be corrected to accurately reflect his reason for separation. Enclosures (1) and (2) apply.

2. The Board, consisting of ██████████, ██████████, and ██████████, reviewed Petitioner's allegations of error and injustice on 9 December 2024 and, pursuant to its regulations, determined that the corrective action indicated below should be taken. Documentary material considered by the Board consisted of Petitioner's application together with all material submitted in support thereof, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. Although enclosure (1) was not filed in a timely manner, it is in the interest of justice to review the application on its merits.

c. Petitioner enlisted in the Navy and began a period of active service on 1 June 1989. Administrative remarks in his Official Military Personnel File indicate he was administratively separated due to parenthood. He was Honorably discharged on 1 November 1992 and issued a DD Form 214 indicating his separation authority as "3620270;" which corresponds to "physical disability,

d. Petitioner contends the separation authority on his DD Form 214 in in error and should instead be "3620210," which corresponds to "parenthood."

CONCLUSION

Upon careful review and consideration of all of the evidence of record, the Board determined that Petitioner's request warrants partial relief. Specifically, as previously discussed, the Board noted Petitioner's DD Form 214 erroneously documents his separation authority as "3620270." The Board agreed this authority is in error but determined Petitioner's correct authority should be "3620200," which corresponds to "Parenthood." The Board additionally determined Petitioner's SPD code should be changed to "GDG" to correspond with the corrected separation authority.

In view of the above, the Board directs the following corrective action.

RECOMMENDATION

That Petitioner be issued a DD Form 215 indicating his correct separation authority of "3620200," and SPD code of "GDG."

That no further changes be made to Petitioner's record.

That a copy of this report of proceedings be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulation, Section 723.6(e)) and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of reference (a), has been approved by the Board on behalf of the Secretary of the Navy.
