- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting correction of her military medical record by removing an erroneous entry.
- 2. The Board, consisting of provided pr
- 3. The Board, having reviewed all of the evidence of record pertaining to Petitioner's allegations of error or injustice, finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulation within the Department of the Navy.
- b. During a 25 February 2022 appointment at Naval Medical Center, Mental Health Clinic, Petitioner's mental health provider indicated in the record's "Past Psychiatric History" that Petitioner had a previous hospitalization. See enclosure (2)<sup>1</sup>.
- c. Petitioner contends the "yes" marking for "previous hospitalization" is in error and is preventing her from being able to join the Air Force Reserves. In support of this contention, the mental health provider that made the erroneous entry provided enclosure (3), a letter explaining she "incorrectly marked 'yes' to a yes or no question about previous hospitalization." Further, the provider noted that "based on [her] clinical assessment findings at that time, [Petitioner] did not have any past problems or therapies for emotional, behavioral, or substance use" and had "never had a psychiatric hospitalization."

## CONCLUSION

Upon careful review and consideration of all of the evidence of record, the Board concluded Petitioner is entitled to relief. Relying on the mental health provider's letter at enclosure (3), the Board determined the "yes" indication for "past hospitalization" is in error.

## RECOMMENDATION

In view of the above, the Board recommends the following corrective action be taken on Petitioner's naval record.

That Navy Personnel Command (NPC) direct appropriate action be taken to correct Petitioner's military medical record, specifically the entry dated 25 February 2022 which reflects Petitioner's "Past Psychiatric History", be corrected to reflect "no" for "previous hospitalizations."

NPC will <u>not</u> file this report of proceedings in Petitioner's naval record.

- 5.
