1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show that Petitioner reenlisted on 11 September 2024 and was eligible for and received a zone "C" Selective Retention Bonus (SRB) and Aircraft Maintenance Kicker - AMK.

2. The Board, consisting of ██████████, ██████████, and ██████████ reviewed Petitioner's allegations of error and injustice on 10 July 2025 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 13 September 2010, Petitioner entered active duty.

b. On 20 October 2015, Petitioner was assigned Primary Military Occupational Specialties (PMOS) 6338. On 26 October 2016, Petitioner was assigned ADMOS1 6018.

c. On 19 January 2019, Petitioner reenlisted for 4 years and 9 months with an Expiration of Current Contract (ECC) of 18 October 2023 and received a zone A SRB.

d. On 28 March 2022, Petitioner was assigned ADMOS2 0951.

e. In accordance with reference (b), this MARADMIN announced the SRB Program and the Broken Service SRB Program authorized for the FY24 retention campaign which began on 1 June 2023. Marines with an ECC from 1 October 23 to 30 September 24 were encouraged to thoroughly review the contents of this MARADMIN. Aircraft Maintenance Kicker. Gunnery Sergeants and below in zones A, B, or C within the 61xx, 62xx, 63xx, 6531 Primary Military Occupational Specialties (PMOS) are eligible and will rate a \$25,000 kicker in addition to the PMOS bonus amount listed in paragraph(s) 6.a, 6.b, and 6.c. If no PMOS bonus is listed, the Marine rates the lump sum kicker of \$25,000. The following conditions must be met: 1) must possess at least one Necessary MOS (NMOS) and current qualification of: 6012-Safe For Flight (SFF) Controller, 6016-Collateral Duty Inspector (CDI), 6017- Collateral Duty Quality Assurance Representative (CDQAR), 6018-Quality Assurance Representative (QAR), or 6242-Flight Engineer; 2) reenlist for 48 months; and 3) must be currently assigned to the below Monitored Command Codes (MCC), and agree to remain in a specified MCC for the first 24 months (following the end of their current contract). MCCs authorized for the Aircraft Maintenance Kicker: "...V6A...VF2..." Zone C applies to those active component Marines with 10 to 14 years of active military service. Marines with exactly 14 years of active service on the date of reenlistment may be paid a zone C PMOS bonus if they have not previously received a zone C PMOS bonus. Furthermore, a zone "C" SRB for MOS 6338, E-7 and above, which is capped at \$18,360 for 48 months of additional obligated service was authorized.

f. On 1 July 2023, Petitioner transferred from MCC [REDACTED] and arrived to MCC [REDACTED] on 19 August 2023 for duty.

g. On 18 August 2023, Petitioner signed an agreement to extend enlistment for 21 months with an End of Active Service (EAS) of 18 July 2025 in order to have obligated service for promotion.

h. On 22 August 2023, Petitioner signed an agreement to extend enlistment for 2 months with an EAS of 18 September 2025 in order to have obligated service for promotion.

i. On 1 September 2023, Petitioner was promoted to Gunnery Sergeant/E-7.

j. In accordance with reference (c), this MARADMIN announced changes to reference (b). This update to the FY24 SRB Program supports the Service's evolving retention culture based on Fleet Marine Force requirements, providing Marines with proven performance and desired skills an opportunity to reenlist earlier in their careers. This MARADMIN broadens the reenlistment eligible population and provides amplified kicker information as detailed below: 3.a.(1). Marines whose expiration of current contract is in FY24 and FY25 (1 October 2023 to 30 September 2025).

k. In accordance with reference (d) (9 October 2024), this MARADMIN announced the SRB Program and the Broken Service SRB Program authorized for enlisted Marines reenlisting in FY25. Marines with an ECC from 10 October 2024 to 30 September 2025 were encouraged to thoroughly review the contents of this MARADMIN. Zone D applies to those

active component Marines with 14 to 18 years of active military service. Marines with exactly 18 years of active service on the date of reenlistment may be paid a zone D PMOS bonus if they have not previously received a zone D PMOS bonus. Furthermore, no zone "D" SRB for MOS 6338, E-7 and above, was authorized.

l. On 11 June 2024, Petitioner signed a Reenlistment Extension Lateral Move Request (NAVMC 11537) for a 48-month reenlistment and a zone C SRB. The Commanding Officer recommended approval of the request on 24 June 2024.

m. On 25 June 2024, Petitioner's Careerist Active Duty Reenlistment request was submitted to Headquarters, U.S. Marine Corps (HQMC).

n. On 13 September 2024, Petitioner entered zone D.

o. On 20 November 2024, Petitioner's reenlistment request was approved by HQMC. Approved MOS: 6338.

p. On 3 December 2024, Petitioner reenlisted for 4 years and 8 months with an ECC of 2 August 2029.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 25 June 2024, Petitioner's command submitted a 48-month reenlistment in PMOS 6338 to HQMC while still in zone C. In accordance with enclosure (2), Petitioner's request was held due to lack of funding. Petitioner entered zone D on 13 September 2024. HQMC approved Petitioner's Reenlistment request on 20 November 2024, making him ineligible to receive a zone C SRB or Aircraft Maintenance Kicker. The Board determined availability of funding would have prevented this issue.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner was discharged and reenlisted on 10/11 September 2024 vice 2/3 December 2024 for a term of 4 years and 11 months vice 4 years and 8 months.

Note: This change will entitle the member to a zone C SRB for PMOS 6338, E-7 and above, which is capped as \$18,360 for 48 months of additional obligated service. Remaining obligated service to 18 July 2025 will be deducted from SRB computation. Furthermore, this change will entitle the member to \$25,000 Aircraft Maintenance Kicker.

A copy of this report of proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above titled matter.
