1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that her naval record be corrected to reflect Home of Record (HOR) as [REDACTED], [REDACTED] (USA) vice [REDACTED] ([REDACTED]) ([REDACTED]).

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 17 July 2025 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, she exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:

a. On [REDACTED], Petitioner was born at [REDACTED] in [REDACTED], [REDACTED], [REDACTED].

b. On 14 March 2012, Petitioner enlisted in the Naval Reserve for 8 years. Petitioner's DD Form 4, Enlistment/Reenlistment Document reflects HOR: [REDACTED], [REDACTED] ([REDACTED]) [REDACTED]. DD Form 1966, Record of Military Processing outlined current address as [REDACTED], [REDACTED], [REDACTED], [REDACTED], [REDACTED] and HOR as [REDACTED], [REDACTED], [REDACTED], [REDACTED].

c. On 18 September 2012, Petitioner entered active duty.

d. Petitioner reenlisted for 4 years on 28 March 2016, and 20 December 2020 respectively. Both reenlistment documents listed HOR as [REDACTED], [REDACTED].

e. On 15 March 2024, Petitioner reenlisted for 4 years with HOR listed as [REDACTED], [REDACTED].

f. In correspondence attached as enclosure (2), the office having cognizance over the subject matter addressed in Petitioner's application has commented to the effect that the request has merit and a request was submitted to update the record to reflect [REDACTED], [REDACTED], [REDACTED], United States.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded Petitioner's HOR was erroneously listed as [REDACTED], [REDACTED], [REDACTED], [REDACTED] on DD Form 1966, incorrectly entered in Petitioner's electronic service records and subsequently inaccurately listed on Petitioner's reenlistment documents. Petitioner's HOR was [REDACTED], [REDACTED] [REDACTED] at the time of enlistment and correction to the HOR meets the criteria outlined in reference (b).¹ Therefore, the Board determined that under these circumstances, relief is warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's DD Form 1966, Record of Military Processing is amended to reflect HOR as [REDACTED], [REDACTED], [REDACTED], [REDACTED], United States, [REDACTED] vice [REDACTED], [REDACTED], [REDACTED], [REDACTED], [REDACTED].

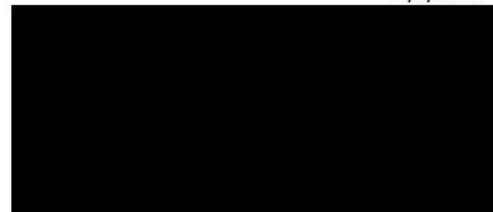
Note: Navy Personnel Command is authorized to correct any other entries affected by the Board's decision.

¹ In the case of a correction to the HOR (for officer and enlisted) may be authorized in those instances when, through a bona fide error, the place originally named at time of current entry into the Service was not in fact the actual home. Any such correction must be fully justified and the home, as corrected, must be the actual home of the member upon entering the Service, and not a different place selected for the member's convenience and in the electronic service records.
