1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board) requesting correction of his date of birth on his Certificate of Release or Discharge from Active Duty (DD Form 214).

2. The Board consisting of ██████████, reviewed Petitioner's allegations of error and injustice on 9 May 2025 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of his naval service records, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, the Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. Although enclosure (1) was not filed in a timely manner, the statute of limitations was waived in the interests of justice.

c. Petitioner enlisted in the Navy Reserve and completed a period of Honorable active duty from 31 December 1957 to 25 November 1959. At the time of his service, his Date of Birth (DOB) was reflected as ██████████

d. Petitioner's record contains a DD Form 214 for his period of service that erroneously indicates his DOB as ██████████

e. Petitioner provided a Certificate of Birth which substantiates his date of birth as ██████████

CONCLUSION:

Upon review and consideration of all the evidence of record, the Board concludes that Petitioner's request warrants relief. As previously discussed, Petitioner's DD Form 214 erroneously documents his date of birth and requires correction.

RECOMMENDATION:

In view of the above, the Board directs the following corrective action:

Petitioner be issued a correction to DD Form 214, Certificate of Release or Discharge from Active Duty (DD Form 215) to indicate, for the period ending 25 November 1959, his date of birth as [REDACTED].

No further changes be made to Petitioner's record.

A copy of this report of proceedings be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5.
