- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting removal of the Administrative Remarks (6105) counseling entry dated 25 June 2024.
- 2. The Board, consisting of reviewed Petitioner's allegations of error and injustice on 4 June 2025, and pursuant to its regulations, determined the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval records, and applicable statutes, regulations, and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulation within the Department of the Navy.
- b. Petitioner was issued enclosure (2), 6105 counseling entry, on 25 June 2024, counseling him after he failed to successfully pass the three mile run on the 21 June 2024 Physical Fitness Test (PFT). Additionally, on the same date, Petitioner was issued enclosure (3), a Page 11 acknowledging he was eligible but not recommended for promotion to staff sergeant due to his PFT failure. Petitioner elected to submit a written statement in rebuttal to these entries. In his statement, he explained that he was injured during the PFT and immediately sought medical attention, first at base medical then at the local emergency room, enclosure (4).

c. Petitioner contends the erroneous 6105 counseling entry at enclosure (2) should be removed because, during the PFT, he sustained an injury to his right hamstring which, after multiple medical visits, resulted in approximately 74 days of light duty. In support of his request, Petitioner submitted enclosure (5) which reflects the concurrence of Commanding Officer, Marine Heavy Helicopter Squadron 465, that the counseling entry and failed PFT should be removed from Petitioner's service record. Enclosures (1) and (5).

CONCLUSION

Upon review and consideration of all the evidence, the Board determined Petitioner's request warrants relief. Relying on enclosure (5), the Board determined the 6105 counseling entry, Page 11 entry regarding promotion, and associated rebuttal at enclosures (2) - (4) should be removed from Petitioner's official military personnel file.

RECOMMENDATION

In view of the above, the Board recommends the following corrective action.

Petitioner's naval record be corrected by removing enclosures (2), (3), and (4).

- 4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.

Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulation, Section 723.6(e)) and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of reference (a), has been approved by the Board on behalf of the Secretary of the Navy.
