
Dear Petitioner:

This is in reference to your application for correction of your naval record pursuant to Section 1552 of Title 10, United States Code. After careful and conscientious consideration of relevant portions of your naval record and your application, the Board for Correction of Naval Records (Board) found the evidence submitted insufficient to establish the existence of probable material error or injustice. Consequently, your application has been denied.

A three-member panel of the Board, sitting in executive session, considered your application on 13 August 2025. The names and votes of the members of the panel will be furnished upon request. Your allegations of error and injustice were reviewed in accordance with administrative regulations, and procedures applicable to the proceedings of this Board. Documentary material considered by the Board consisted of your application, together with all material submitted in support thereof, relevant portions of your naval record, and applicable statutes, regulations, and policies, as well as the decision furnished by the Marine Corps Performance Evaluation Review Board (PERB) and the decision Records and Performance Branch. Although you were afforded an opportunity to submit a rebuttal, you chose not to do so.

The Board carefully considered your request to modify your fitness report for the reporting period fitness report for the reporting period 2 October 2021 to 31 December 2021 by increasing the attribute marks for Developing Subordinates, Ensuring Well-Being of Subordinates, Communication Skills, and PME. The Board considered your statement that your Reporting Senior (RS) had a below average fitness report contested and removed from his profile, which dropped your fitness report to below average, and you are trying to have the subject fitness report corrected to show that you are not a below average Staff Sergeant.

The Board, however, substantially concurred with the PERB's decision that you did not demonstrate probable material error, substantive inaccuracy, or injustice warranting modification of your fitness report. The Board determined that your fitness report is valid as written and filed in accordance with the applicable Marine Corps Performance Evaluation System (PES) Manual. The Board noted the correspondence from your former RS but found it unpersuasive. In this regard, an adjustment to the RS's profile and your relative value due to the removal of a fitness



report does not constitute a material error or injustice warranting a substantive correction. The PES Manual does not provide a mechanism to reset an RS's profile to increase the perceived competitiveness of a fitness report or future profile placement. Moreover, the requested change would have a negative impact on other Marines in the RS's profile. The Board thus concluded there is no probable material error, substantive inaccuracy, or injustice warranting corrective action. Accordingly, given the totality of the circumstances, the Board determined that your request does not merit relief.

You are entitled to have the Board reconsider its decision upon submission of new matters, which will require you to complete and submit a new DD Form 149. New matters are those not previously presented to or considered by the Board. In this regard, it is important to keep in mind that a presumption of regularity attaches to all official records. Consequently, when applying for a correction of an official naval record, the burden is on the applicant to demonstrate the existence of probable material error or injustice.
