- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that her naval record be corrected by changing a Physical Readiness failure mark for the evaluation report covering the period 16 November 2021 to 15 November 2022, enclosure (2), and a mark of a Physical Readiness Test (PRT) failure from her Performance Summary Report (PSR), enclosure (5), to reflect she passed the event.
- 2. The Board, consisting of _______, reviewed Petitioner's allegations of error and injustice on 20 March 2025 and, pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval records, and applicable statutes, regulations, and policies.
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulation within the Department of the Navy.
- b. For Physical Fitness Assessment (PFA) Cycle 2022, Petitioner was injured, granted a medical waiver, and did not complete the cardio modality event of the PRT. Enclosure (2) is a Periodic/ Regular report, which states in block 20 that Petitioner was a Physical Readiness failure. Petitioner's PSR, enclosure (5), also states that Petitioner failed the PRT during the reporting period in question.
- c. Petitioner contends enclosures (2) and (5) are erroneous as her PFA Summary Report, enclosure (6), reflects a "Pass" for her Body Composition Assessment (BCA) and a "Partial

Pass" for her PRT for PFA cycle 1-2022. To support her contention, Petitioner included a 5 December 2024 letter from Commander Fleet Logistics Support Wing, enclosure (4), endorsing the request to change Petitioner's PFA from Failure to Partial Pass because the Command Fitness Leader did not route the medical waiver for commanding officer (CO) or Officer In Charge (OIC) endorsement resulting in the incorrect annotation in the Physical Readiness Information Management System (PRIMS).

d. Enclosure (4), an advisory opinion (AO) furnished by PERS-32 recommends the Board to direct removal of the PFA failure from enclosure (2) and to remove the record of a PRT failure from the PSR, enclosure (5).

CONCLUSION

Upon review and consideration of all the evidence of record, the Board determined that Petitioner's request warrants relief. The Board noted the Petitioner provided evidence of errors in her record with respect to her PR failure notation on her evaluation and PRT failure on her PSR. In addition, the Board concurred with the AO that it merits correction.

RECOMMENDATION

In view of the above, the Board recommends the following corrective action.

That block 20 of enclosure (2) be corrected to reflect a Physical Readiness of Partial Pass.

That the "PRT" block for the reporting period 16 November 2021 to 15 November 2002 of enclosure (5) be changed to reflect Petitioner partially passed the PRT.

- 4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
- 5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of reference (a), has been approved by the Board on behalf of the Secretary of the Navy.
