1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show he reenlisted on 20 September 2024 and was eligible for and received a zone B Selective Retention Bonus (SRB).	
2. The Board, consisting of, and, and reviewed Petitioner's allegations of error and injustice on 28 August 2025 and pursuant to its regulations, determined	

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of

- a. On 22 September 2014, Petitioner entered active duty.
- b. On 17 October 2018, Petitioner was assigned ADMOS1 8411.

Petitioner's naval record, and applicable statutes, regulations, and policies.

- c. On 22 September 2020, Petitioner entered zone B.
- d. On 21 July 2021, Petitioner reenlisted for 4 years with an Expiration of Current Contract (ECC) of 20 July 2025.

- e. On 15 December 2021, Petitioner was assigned Primary Military Occupational Specialties (PMOS) 3152. On 12 January 2022, Petitioner was assigned ADMOS2 3112.
  - f. On 1 November 2022, Petitioner was promoted to Staff Sergeant/E-6.
- g. In accordance with reference (b), announced the SRB Program and the Broken Service SRB Program authorized for the FY24 retention campaign which began on 1 June 2023. Marines with an ECC from 1 October 23 to 30 September 24 were encouraged to thoroughly review the contents of this MARADMIN. Zone B applies to those active component Marines with 6 to 10 years of active military service. Marines with exactly 10 years of active service on the date of reenlistment may be paid a zone B PMOS bonus if they have not previously received a zone B PMOS bonus. Furthermore, a zone B SRB for MOS 3152, E-6 and above, which is capped at \$17,000 for 48 months of additional obligated service was authorized.
- h. In accordance with reference (c), announced changes to reference (b). This update to the FY24 SRB Program supports the Service's evolving retention culture based on Fleet Marine Force requirements, providing Marines with proven performance and desired skills an opportunity to reenlist earlier in their careers. This MARADMIN broadens the reenlistment eligible population and provides amplified kicker information as detailed below: 3.a.(1). Marines whose expiration of current contract is in FY24 and FY25 (1 October 2023 to 30 September 2025).
- i. On 24 July 2024, Petitioner's Careerist Active Duty Reenlistment request was submitted requesting 48 month reenlistment and zone B SRB.
  - j. On 22 September 2024, Petitioner entered zone C.
- k. In accordance with reference (d), announced the SRB Program and the Broken Service SRB Program authorized for enlisted Marines reenlisting in FY25. Marines with an ECC from 10 October 2024 to 30 September 2025 were encouraged to thoroughly review the contents of this MARADMIN. Zone B applies to those active component Marines with 6 to 10 years of active military service. Marines with exactly 10 years of active service on the date of reenlistment may be paid a zone B PMOS bonus if they have not previously received a zone B PMOS bonus. Furthermore, a zone B SRB for MOS 3152, E-6 and above, which is capped at \$17,000 for 48 months of additional obligated service was authorized.
- 1. On 24 July 2024, Petitioner's Careerist Active Duty Reenlistment request was approved by Headquarters, U.S. Marine Corps (HQMC) on 10 December 2024. Approved MOS: 3152.
- m. On 13 December 2024, Petitioner reenlisted for 4 years and 8 months with an ECC of 12 August 2029.

## CONCLUSION

Upon review and consideration of all the evidence of record and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following

corrective action. The Board concluded that on 24 July 2024, Petitioner's command submitted requesting a 48 month reenlistment and zone B SRB. On 22 September 2024, Petitioner entered zone C. In accordance with enclosure (2), the request was held due to *lack of funding*. Petitioner was subsequently approved by HQMC on 10 December 2024 for a 48 month reenlistment without the SRB. The Board determined that availability of SRB funding likely would have prevented this issue.

## RECOMMENDATION

That Petitioner's naval record be corrected where appropriate to show that:

Petitioner was discharged and reenlisted on 19/20 September 2024 vice 12/13 December 2024 for a term of 4 years and 11 months vice 4 years and 8 months.

Note This change will entitle the member to a zone B SRB for PMOS 3152, E-6 & above, which is capped as \$17,000 for 48 months of additional obligated service. Remaining obligated service to 20 July 2025 will be deducted from SRB computation.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

- 4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.
- 5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
