1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to establish eligibility to transfer Post-9/11 GI Bill education benefits to his eligible dependents effective 18 August 2015.

2. The Board, consisting of [REDACTED], [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 14 August 2025 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:

a. The Post-9/11 Veterans Educational Assistance Act (Post-9/11 GI Bill, Public Law 110-252) was signed into law on 30 June 2008 and became effective on 1 August 2009. The bill provides financial support for education and housing for service members with at least 90 days of service on or after 11 September 2001. The act also includes provision for qualifying service members to transfer education benefits to their eligible dependents. General descriptions of the essential components of the law were widely available, beginning in summer 2008, but specific implementing guidance was not published until summer 2009.

b. In accordance with reference (c), the option to transfer a Service member's unused education benefits to an eligible dependent requires a 4-year additional service obligation at the time of election. Additionally, all officers were required to have a NAVPERS 1070/613,

Administrative Remarks, prepared by their command in the Navy Standard Integrated Personnel System Electronic Service Record (ESR) agreeing to serve the required additional years of service prior to initiating their electronic transfer election. Furthermore, the policy directed members to complete/submit electronic transfer election using the TEB web application at <https://www.dmdc.osd.mil/milconnect>.

c. Reference (d), updated the TEB process by establishing an online, self-service Statement of Understanding that replaced the NAVPERS 1070/613, Administrative Remarks effective 1 October 2018.

d. On 27 May 2005, Petitioner accepted an active commission and entered active duty.

e. On 20 June 2008, Petitioner married [REDACTED], and they had four children:

f. On 18 August 2015, Petitioner signed "Post 9-11 GI Bill" NAVPERS 1070/613, Administrative Remarks agreeing to complete four additional years of service in the Armed Forces from date of election. The document was uploaded to Petitioner's ESR and verified on 28 August 2015.

g. On 11 August 2025, Navy Personnel Command (PERS-311) advised the Board that Petitioner has never submitted a TEB application.

h. Petitioner approved to transfer to the Retired List effective 1 March 2026.

CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting the following corrective action. Petitioner met the basic eligibility criteria to transfer Post-9/11 GI Bill education benefits but failed to complete the administrative requirements outlined in references (c) and (d). Although Petitioner did not complete the appropriate administrative requirements, the Board determined his completion of the required NAVPERS 1070/613, Administrative Remarks on 18 August 2015 and continued active duty service meets the spirit and intent of reference (b), therefore, under these circumstances, relief is warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner elected to transfer unused education benefits to [REDACTED]/7 months, [REDACTED]
[REDACTED]/7 months, [REDACTED]/7 months, and [REDACTED]/7 months through the MilConnect
TEB portal on 18 August 2015. Note: Petitioner allocated education benefits to [REDACTED]
[REDACTED]/7 months after date of birth on 17 July 2017.

Commander, Navy Personnel Command (PERS-311) reviewed Petitioner's TEB application, and it was approved on 18 August 2015 with a 4-year service obligation. Note: PERS-311 will ensure Petitioner's Benefits for Education Administrative Services Tool Family Member History is updated with the aforementioned approved allocation of education benefits.

A copy of this report of proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above titled matter.
