1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to establish entitlement to the Loan Repayment Program (LRP).

2. The Board, consisting of [REDACTED], and [REDACTED] reviewed Petitioner's allegations of error and injustice on 25 September 2025 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:

a. In July 2008, Petitioner was awarded an Associate of Arts from Imperial Valley College.

b. On 19 August 2022, Petitioner enlisted in the Navy for a term of 8 years of which 4 years is considered an active duty obligation. NAVCRUIT 1133/52, Enlistment Guarantees – Annex "A" was issued listing Aviation Ordnanceman (AO/5YO) Class "A" School Guarantee (T+X) that required a voluntary extension for 12 months, LRP up to \$65,000, and Enlistment Bonus for Shipping (EBSHP) - \$10,000 Bonus; however, the Annex was not provided to the Navy Recruiting Command LRP Program Manager for approval and copy was not uploaded to Petitioner's Official Military Personnel File (OMPF). Petitioner's DD Form 1966, Record of Military Processing reflects Aviation Ordnanceman (AO/5YO) Class "A" School Guarantee (T+X), \$10,000 EBSHP, Active Duty Service Date of 13 September 2022 and Armed Forces Qualification Test score of 72. Additionally, Petitioner signed Navy Recruiting District Request to Add LRP Option form, NAVCRUIT 1133/75, Statement of Understanding LRP, and DD

Form 2475, DOD Educational LRP Annual Application, authorizing the release of his financial data by the lender. The lender's certifying official signed the Petitioner's DD Form 2475 on 8 September 2022.

c. On 13 September 2022, Petitioner entered active duty. Petitioner signed a 12 month extension and a subsequent Annex "A" listing Aviation Ordnanceman (AO/5YO) Class "A" School Guarantee (T+X) that required a voluntary extension for 12 months, and Enlistment Bonus for Shipping (EBSHP) - \$10,000 Bonus only.

d. 22 November 2022, Petitioner's Master Military Pay Account reflects \$10,000 enlistment bonus was processed for payment.

e. On 23 November 2022, Petitioner completed Recruit Basic Military Training.

f. On 2 March 2023, Petitioner completed AO "A" School, followed by completion of AO "C" School on 6 April 2023.

g. On 8 April 2023, Petitioner reported to his first permanent duty station, [REDACTED] for duty.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. Petitioner met the eligibility criteria for LRP in accordance with reference (b).¹ However, because LRP was not annotated on the Petitioner's Annex "A" within his OMPF, he was deemed ineligible to receive the incentive. Although proper administrative requirements were not completed, the Board determined that under this circumstance, relief is warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's NAVCRUIT 1133/52, Enlistment Guarantees – Annex "A" to DD Form 4 dated 19 August 2022, signed on 13 September 2022 is amended to reflect Option 3: "Loan Repayment Program – Up to \$65,000."

Petitioner completed and submitted all required Loan Repayment Program (LRP) documents to cognizant authorities in a timely manner. Note: To complete the process, Petitioner must contact the Navy Recruiting Command (NRC) LRP Program Manager at cnrc_lrp-eb@navy.mil with contact information to include address, email, and phone numbers. Additionally, Petitioner

¹ Any future Sailor initially classified or reclassified on or after 5 August 2022 in any rating/programs that shipped October through September of any fiscal year were eligible for LRP up to \$65,000. Future Sailors must access to Active Component and have LRP listed as a guarantee in their current Annex to DD Form 4, Enlistment/Reenlistment Document in order to maintain eligibility.

must provide the NRC LRP Program Manager with lender signed copies of updated DD Form 2475 and a copy of this letter.

A copy of this report of proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above titled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
