1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show Petitioner's immediate reenlistment contract executed on 17 January 2025 was cancelled, and that he signed an agreement to extend enlistment in order to meet the service obligation in official change duty orders (BUPERS order: 2764).

2. The Board, consisting of ██████████, ██████████, and ██████████ reviewed Petitioner's allegations of error and injustice on 4 September 2025 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. In accordance with reference (b), if the current SRB NAVADMIN publishes the use of zones, the guidance regarding zones in table 1-1 must be adhered to. A member may receive only one SRB per zone during a career. When reenlisting for SRB, the reenlistment must take the member's new End of Active Obligated Service (EAOS) into the next SRB zone.

b. On 3 October 2019, Petitioner entered active duty.

c. In March 2020, Petitioner was awarded Navy Enlisted Classification (NEC) H0A1. In May 2020, Petitioner was awarded NEC 745A.

d. On 7 July 2022, Petitioner reenlisted for 4 years with an EAOS of 6 July 2026 and received a zone A SRB.

e. In December 2022, Petitioner was awarded NEC 746A. In April 2023, Petitioner was awarded NEC 735A.

f. On 2 October 2024, Petitioner was issued official change duty orders (BUPERS order: 2764) with required obligated service to July 2028, while stationed in [REDACTED] with an effective date of departure of February 2025. Petitioner's intermediate (01) activity was [REDACTED] for temporary duty under instruction with an effective date of arrival of 4 March 2025. Petitioner's ultimate activity was [REDACTED] for duty with an effective date of arrival of 12 July 2025 with a projected rotation date of July 2028. Obligated service to August 2024, is required for this assignment which may be satisfied by reenlistment or extension of enlistment.

g. On 11 December 2024, Petitioner signed a command career request (NPPSC 1160/1) requesting a 6-year reenlistment effective 17 January 2025, and a zone A SRB. Petitioner's request was approved by cognizant authority on 23 December 2024.

h. On 17 January 2025, [REDACTED] issued Petitioner an Administrative Remarks (NAVPERS 1070/613) listing the following: "Entitled to SRB based on the IT Rating/NEC 735A, SRB zone A. Award Level 2.5. The total SRB entitlement is \$ 39568.50. First installment of \$ 19784.25 will be deposited to your DDS account by EFT payment when the entitlement has posted to the Master Pay Account."

i. On 17 January 2025, Petitioner reenlisted for 6 years with an EAOS of 16 January 2031.

j. On 28 February 2025, Petitioner transferred from [REDACTED] and arrived at [REDACTED] on 4 March 2025 for temporary duty.

k. In May 2025, Petitioner was awarded NEC 723B.

l. On 16 May 2025, Petitioner transferred from S [REDACTED] and arrived at [REDACTED] on 11 June 2025 for duty.

m. On 3 October 2025, Petitioner entered zone B.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 7 July 2022, Petitioner reenlisted for 4 years and received a zone A SRB. On 2 October 2024, Petitioner was issued orders 2764 with required obligated service to July 2028. On 17 January 2025, Petitioner reenlisted for 6 years. At that time, Petitioner was erroneously approved for a zone A SRB. In accordance with reference (b), a member may receive only one SRB per zone in a career. The Board determined that Petitioner

should have been advised to sign an extension of enlistment to meet the obligated service vice reenlist.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's 6-year immediate reenlistment contract (NAVPERS 1070/601) executed on 17 January 2025 is null and void.

Petitioner signed an agreement to extend enlistment (NAVPERS 1070/621) for 24 months, operative on 7 July 2026.

Note: This will establish an EAOS of 6 July 2026 and Soft EAOS of 6 July 2028.

A copy of this Report of Proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above-entitled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
