1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to show Petitioner's initial enlistment contract was for a term of 4 years with a 24 months extension of enlistment.

2. The Board, consisting of ██████████, ██████████ and ██████████ reviewed Petitioner's allegations of error and injustice on 2 December 2025 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. In accordance with reference (b), General. AEF/ATF Program options are incentives for enlistment into the regular Navy and provide Class "A" School, advancement to paygrade E2 and advanced training of various lengths. Program specifics for special warfare operator, special warfare boat operator, explosive ordnance disposal, navy diver, and aircrew rescue swimmer are contained in volume IV, chapter 1, section 3. Program specifics for the Aircrewman Program are contained in volume IV, chapter 1, section 7. IAW MILPERSMAN Article 1133-090, New Accession Training Sailors graduating from AEF/ATF training pipelines are eligible for advancement in the same manner as their active component (AC) counterparts. Term of Enlistment. Applicants will enlist for four years and concurrently execute an agreement to extend their enlistment for 24 months.

b. On 17 December 2020, Petitioner signed an Enlistment/Reenlistment – Document Armed Forces of the United States (DD Form 4) listing the following: block B8 (Agreements) “I am enlisting/reenlisting in the United States (list branch of service) Navy Reserve this date for 8 years, 0 months, and 0 weeks beginning in pay grade E-3 of which 6 years, 0 months, and 0 weeks is considered an Active Duty Obligation, and 2 years, 0 months, and 0 weeks will be served in the Reserve Component of the Service in which I have enlisted.”

c. On 17 December 2020, Petitioner signed an Enlistment Guarantee (NAVCRUIT 1133/52) Annex A to DD Form 4 dated 17 December 2020 acknowledging the following: “ACKNOWLEDGEMENT: In connection with my enlistment into the United States Navy (Active) Component. I hereby acknowledge that I am enlisting for a total Military Service Obligation (MSO) of 8 years. I fully understand and acknowledge that my MSO consists of an active duty obligation of 6 years as indicated in the options listed below with the remaining 24 months of my MSO served in either the Selected Reserve (SELRES) or Individual Ready Reserve (IRR) In any case. I may be ordered to the SELRES for the remainder of my MSO based on the needs of the Navy (AC only). I understand my contract has the following guaranteed options which require the indicated active duty service obligations): Option 1; Advanced Technical Field Cryptologic Technician - Interpretive (ATF/CTI 6YO) Program - requires 4 years active duty obligation and a voluntary extension of 24 program guarantee active duty obligation requirement. Option 2: Enlistment Bonus for Source Rate (EBSR) \$25,000 Bonus.”

d. On 29 June 2021, Petitioner signed an agreement to extend enlistment for 24 months with a Soft End of Active Obligated Service (EAOS) of 28 June 2027 in order to “Training in the Advanced Electronic Field (AER/Advanced Technical Field (ATF) Program and advancement to paygrade E4 per MILPERSMAN Articles 1160-040 and 1510-030. I understand that this extension becomes binding upon execution and thereafter may not be cancelled except as set forth in MILPERSMAN Article 1160-040. In particular, I understand that when I accept advancement to E4, 12 months of this agreement may not be cancelled whether or not I complete advanced training.”

e. On 29 June 2021, Petitioner entered active duty for 4 years with an EAOS of 28 June 2025 and Soft EAOS of 28 June 2027.

f. On 28 November 2025, Navy Standard Integrated Personnel System (NSIPS)/Electronic Service Record (Member Data Summary/Contract Information) shows an EAOS of 28 June 2027 and Soft EAOS of 18 June 2029.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 17 December 2020, Petitioner entered the Navy Delayed Entry Program in the AEF/CTI 6YO program, requiring a 4-year active duty contract with a 24 month extension. On 29 June 2021, Petitioner entered active duty. Petitioner’s DD Form 4 erroneously lists a 6 year Active Duty contract, therefore NSIPS erroneously reflects the EAOS as 28 June 2027 and Soft EAOS as 28 June 2029 vice EAOS of 28 June 2025 and Soft

EAOS of 28 June 2027. The Board determined that Petitioner's DD Form 4 should reflect 4 year active duty contract vice 6.

#### RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's Enlistment/Reenlistment – Document Armed Forces of the United States (DD Form 4) of 17 December 2020, listed the following: block B8 (Agreements) "I am enlisting/reenlisting in the United States (list branch of service) Navy Reserve this date for 8 years, 0 months, and 0 weeks beginning in pay grade E-3 of which "4" vice "6" years, 0 months, and 0 weeks is considered an Active Duty Obligation, and "4" vice "2" years, 0 months, and 0 weeks will be served in the Reserve Component of the Service in which I have enlisted."

Note: This will establish an EAOS of 28 June 2025 and a Soft EAOS of 28 June 2027. Furthermore, any other entries affected by the Board's recommendation be corrected.

A copy of this report of proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above titled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
