(2) Case summary

- 1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his characterization of service be changed consistent with references (b) and (c).
- 2. The Board, consisting of particles, and pursuant, and particles, reviewed Petitioner's allegations of error on 8 September 2025 and, pursuant to its regulations, determined the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of his naval service records, and applicable statutes, regulations, and policies, to include references (b) and (c).
- 3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:
- a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.
- b. Although enclosure (1) was not filed in a timely manner, the Board found it in the interest of justice to waive the statute of limitations and consider the case on its merits.
- c. Petitioner enlisted in the Navy and began a period of active service on 5 September 1946. He was discharged with an Honorable (HON) characterization of service on 30 July 1948.
- d. Petitioner reenlisted and began a second period of active service on 14 September 1948. After a period of continuous Honorable service, Petitioner immediately reenlisted and commenced a final period of active duty on 12 July 1950.

## Subj: REVIEW OF NAVAL RECORD OF FORMER MEMBER USN,

- e. On 21 May 1951, Petitioner made a sworn statement recounting a sexual assault attempted upon him by a male sailor onboard his ship. Petitioner was able to escape this assault but, in his statement, he also admitted to having engaged in consensual homosexual conduct on three occasions with a different male. Consequently, he was charged with homosexual conduct.
- f. On 31 May 1951, Petitioner requested an undesirable discharge for the good of the service and to escape trial by court-martial. This request was granted and he was so discharged on 17 July 1951.
  - g. Petitioner has no history of misconduct in his official naval record.
- h. Reference (c) sets forth the Department of the Navy's current policies, standards, and procedures for correction of military records following the "don't ask, don't tell" (DADT) repeal of 10 U.S.C. 654. It provides service Discharge Review Boards with the guidance to normally grant requests to change the characterization of service to "Honorable," narrative reason for discharge to "Secretarial Authority," separation code to "JFF," and reentry code to "RE-1J" when the original discharge was based solely on DADT or a similar policy in place prior to enactment of it and there are no aggravating factors in the record, such as misconduct.

## CONCLUSION:

Upon review and consideration of all the evidence of record, the Board concludes Petitioner's request warrants relief. The Board reviewed the application under the guidance provided in references (b) and (c).

The Board noted Petitioner was discharged based solely due to a homosexual admission and found no evidence of aggravating factors in his record. Therefore, the Board found that Petitioner merits full relief under reference (c).

## RECOMMENDATION:

In view of the above, the Board directs the following corrective action:

Petitioner be issued a new Certificate of Release or Discharge from Active Duty (DD Form 214), for the period ending 17 July 1951, indicating he was discharged with an "Honorable" characterization of service, narrative reason for separation of "Secretarial Authority," separation authority of "MILPERSMAN 1910-164," separation code of "JFF," and reentry code of "RE-1J."

That Petitioner be issued an Honorable Discharge Certificate.

That a copy of this report of proceedings be filed in Petitioner's naval record.

4. It is certified a quorum was present at the Board's review and deliberations, and the foregoing is a true and complete record of the Board's proceedings in the above entitled matter.
