1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that her naval record be corrected to change the address listed on Bureau of Personnel Official New Appointment Order (BUPERS Order 3333) issued 29 November 2023.

2. The Board, consisting of [REDACTED], [REDACTED] and [REDACTED] reviewed Petitioner's allegations of error and injustice on 9 December 2025 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. On 2 August 2019, Petitioner married [REDACTED].

b. On 21 July 2022, Closing Disclosure was issued with a closing date of 25 July 2022 listing the following transaction information: Borrower [REDACTED], Seller [REDACTED] and [REDACTED] from [REDACTED], Seller [REDACTED] and [REDACTED] from [REDACTED], and [REDACTED] [REDACTED]. Addendum to Closing Disclosure lists Petitioner as a borrower and address was listed [REDACTED] at the time.

c. On 1 September 2023, Navy Recruiting Command notified Petitioner located in [REDACTED] [REDACTED] that "[y]ou will be commissioned as a Medical Service Corps Officer (2300). You should be proud of the fact that you were selected for this extremely competitive program.

Your commissioning documents will be prepared once your appointment has been confirmed by Office of the Secretary of Defense. Once confirmed, your commissioning documents will be forwarded to the Navy Recruiting District. The District will contact you after receiving the documents in order to set up a time for your commissioning ceremony.

Upon commissioning as an officer in the United States Navy, you will attend Officer Development (ODS) School. This five-week course of instruction provides you with the necessary tools to understand your role as a Naval Officer.”

- d. On 8 September 2023, Petitioner was issued an Officer Appointment Acceptance and Oath of Office (NAVPERS 1000/4) and was appointed a Lieutenant in the active U.S. Navy with a permanent/present grade date of 28 April 2021, and designator code of 2300 (Staff Corps Officer billet requiring Medical Service (Health Care Administration, Medical Allied Science, Optometry, Pharmacy, or Medical Specialist) specialty). Petitioner signed and was witnessed on 27 September 2023.
- e. On 27 September 2023, [REDACTED] issued Petitioner an Administrative Remarks (NAVPERS 1070/613) listing the following: “...Member/Primary Dependent Address... [REDACTED] ...”
- f. On 27 September 2023, Petitioner and witness signed a Report of Home of Record (HOR) and Place from Which Ordered to Active Duty (NAVPERS 1070/74) listing the following: block 1 (Home of Record) ... [REDACTED].
- g. On 27 September 2023, Petitioner signed Form W-4 (2019) listing the following address of ... [REDACTED].
- h. On 27 September 2023, Petitioner signed a State of Legal Residence Certificate (DD Form 2058) listing a Legal Residence/Domicile of ... [REDACTED].
- i. On 27 September 2023, Petitioner and witness signed a Record of Emergency Data (DD Form 93) listing the following: block 4a (Spouse Name) [REDACTED], and block 4b (Address) ... [REDACTED].
- j. On 29 November 2023, Petitioner was issued official new appointment orders, with a home address of ... [REDACTED]. Petitioner’s intermediate (01) activity was [REDACTED] [REDACTED] for temporary duty under instruction with an effective date of arrival of 25 February 2024. Petitioner’s intermediate (02) activity was [REDACTED] [REDACTED] for temporary duty under instruction with an effective date of arrival of 1 April 2024. Petitioner’s ultimate activity was [REDACTED] for duty with an effective date of arrival of April 2024 with a projected rotation date of April 2027.
- k. On 28 March 2024, Petitioner’s Master Military Pay Account (MMPA) listed the following (Basic Allowance for Housing): ENTRY-OPEN-DT 240326 02 04 1 ENTRY-CLSD-DT 240326 02 04 1 CNTRL-CODE 2 ACTN 01 START 230927 STOP 231231 ENTLMT-MM 13,732.46 ENTLMT 13,732.46 ENTLMT-NM 0.00 MNTLY-RATE 4,382.70 ACCOM 1 ZIP-CODE [REDACTED]

1. On 29 March 2024, Petitioner transferred from [REDACTED] and arrived to [REDACTED] on 31 March 2024 for temporary duty.
- m. On 4 April 2024, Petitioner transferred from [REDACTED] and arrived at [REDACTED] on 12 April 2024 for duty.
- n. On 17 April 2024, Petitioner's MMPA listed the following (Basic Allowance for Housing):

- o. On 8 December 2025, Petitioner's Navy Standard Integrated Personnel System/Electronic Service Record, Member Information (Personal Information) listed the following: HOR-State [REDACTED].

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board agreed with reference (b)<sup>1</sup> that the HOR and or place from which called or ordered to active duty (PLEAD) are used to determine a member's entitlement to travel and transportation allowances or other compensations provided by law. When an individual is commissioned, the place recorded as the service members home is considered the HOR and must be listed on NAVPERS 1070/74. Even though Petitioner's NAVPERS 1070/74 lists the address in [REDACTED], the Board agreed Petitioner purchased a home in [REDACTED] prior to commissioning and her spouse's address is listed as [REDACTED] on the DD Form 93. The Board found that it was possible that the documents listing the address in [REDACTED], which Petitioner asserts were not completed by her, could have been completed incorrectly by the recruiter, therefore relief is warranted.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that: Petitioner signed and was witnessed a Report of Home of Record and Place from Which Ordered to Active Duty (NAVPERS 1070/74) on 27 September 2023, listing the following:  
block 1 (Home of Record) "... [REDACTED]" vice "... [REDACTED]."

<sup>1</sup> NAVSO P-6034, Joint Travel Regulations, the HOR and or PLEAD are used to determine a member's entitlement to travel and transportation allowances or other compensations provided by law. To support these entitlements, these places will be documented (as prescribed below) and must not be changed, except as authorized. HOR. a. The place recorded as the Service member's home when commissioned, appointed, enlisted, inducted, or ordered into a tour of active duty. b. The place recorded as the Service member's home when reinstated, reappointed, or reenlisted remains the same as that recorded when commissioned, appointed, enlisted, inducted, or ordered into the tour of active duty, unless there is a break in service of more than 1 full day.
