1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that her naval record be corrected to show that item 8 in Petitioner's Enlistment Contract (DD Form 4) of 27 November 2023 reflects 8 years vice 4 years.

2. The Board, consisting of ██████████ reviewed Petitioner's allegations of error and injustice on 19 February 2026 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

a. Petitioner's Record of Military Processing – Armed Forces of the United States (DD Form 1966) executed on 5 October 2023 listed the following: 18 (Accession Data) block A (Date of Enlistment) 27 November 2023, block B (Active Duty Service Date) 22 January 2024, block C (Pay Entry Date) 22 January 2024, and block D (military service obligation (MSO)) 0800.

b. Petitioner's Enlistment/Reenlistment Document – Armed Forces of the United States (DD Form 4) executed on 27 November 2023 listed the following: B (Agreements) block 8, "I am enlisting/reenlisting in the United States (list branch of service) Navy this date for 4 years."

c. Petitioner's Annex A to DD Form 4 dated 27 November 2023, New Accession Training (NAT) Program Enlistment Guarantee (NAVCRUIT 1133/52) executed on 27 November 2023 listed the following: "ACKNOWLEDGEMENT: In connection with my enlistment into the U. S. Navy Reserve, I hereby acknowledge that: a. I am enlisting into the U. S. Navy Reserve for a period of eight years, six of which will be in an active drilling status as a Selected Reservist and the remaining two years in the non-drilling Individual Ready Reserve (IRR).

b. I am enlisting with the following guarantees and understanding: Upon enlistment. I will be enlisted under the provisions of COMNAVCRUITCOMINS T 1130.8 with the option or options as indicated below: Option (1) [REDACTED] with Class "A" School."

d. Petitioner's Annex B to DD Form 4 dated 27 November 2023, New Accession Training (NAT) Program Enlistment Guarantee (NAVCRUIT 1133/52) executed on 2 February 2024 listed the following: "ACKNOWLEDGEMENT: In connection with my enlistment into the U. S. Navy Reserve, I hereby acknowledge that: a. I am enlisting into the U. S. Navy Reserve for a period of eight years, six of which will be in an active drilling status as a Selected Reservist and the remaining two years in the non-drilling Individual Ready Reserve (IRR).

b. I am enlisting with the following guarantees and understanding: Upon enlistment. I will be enlisted under the provisions of COMNAVCRUITCOMINS T 1130.8 with the option or options as indicated below: Option (1) [REDACTED] with Class "A" School, Option (2) PC EB: 20,000, Option (3) NOSC [REDACTED]; [REDACTED]; [REDACTED]"

e. Petitioner's Annex C to DD Form 4 dated 27 November 2023, New Accession Training (NAT) Program Enlistment Guarantee (NAVCRUIT 1133/52) executed on 23 February 2024 listed the following: "ACKNOWLEDGEMENT: In connection with my enlistment into the U. S. Navy Reserve, I hereby acknowledge that: a. I am enlisting into the U. S. Navy Reserve for a period of eight years, six of which will be in an active drilling status as a Selected Reservist and the remaining two years in the non-drilling Individual Ready Reserve (IRR).

b. I am enlisting with the following guarantees and understanding: Upon enlistment. I will be enlisted under the provisions of [REDACTED] with the option or options as indicated below: Option (1) [REDACTED] with Class "A" School, Option (2) PC EB: 20,000, Option (3) NOSC [REDACTED]; [REDACTED]"

f. Petitioner was released from active duty and transferred to the Navy Reserve with an Honorable character of service and was issued a Certificate of Release or Discharge from Active Duty (DD Form 214) for the period of 22 January 2024 to 16 August 2024 upon completion of required active service. Furthermore, block 6 (Reserve Obligation Termination Date) 26 November 2031.

## CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that in accordance with reference (b), "NAT Program enlistees incur an 8-year MSO. This MSO will consist of the following: a. Initial Active Duty for Training (IADT) (Recruit Training, Apprenticeship Training, "A" School and "C" School if applicable), followed by: b. Six years in the Selected Reserve (SELRES) (which begins when the Sailor reports for IADT), followed by: c. Remainder of MSO in either the SELRES, the IRR, or if approved, recall to ACDU." On 27 November 2023, Petitioner enlisted in the USNR for 8 years with a NAT Program Enlistment Guarantee; however, the DD Form 4 incorrectly listed a term of 4 years. Therefore, the Board determined that relief is warranted.

## RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner's DD Form 4 executed on 27 November 2023 listed the following: B (Agreements) block 8 "I am enlisting/reenlisting in the United States (list branch of service) "Naval Reserve" vice "Navy" this date for "8 years" vice "4 years..."

A copy of this report of proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above titled matter.
5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
