1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to establish eligibility to transfer Post-9/11 GI Bill education benefits to his eligible dependents effective 14 December 2020.

2. The Board, consisting of ██████████ reviewed Petitioner's allegations of error and injustice on 18 December 2025 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, found that, before applying to this Board, he exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board made the following findings:

a. The Post-9/11 Veterans Educational Assistance Act (Post-9/11 GI Bill, Public Law 110-252) was signed into law on 30 June 2008 and became effective on 1 August 2009. The bill provides financial support for education and housing for service members with at least 90 days of service on or after 11 September 2001. The act also includes provision for qualifying service members to transfer education benefits to their eligible dependents. General descriptions of the essential components of the law were widely available, beginning in summer 2008, but specific implementing guidance was not published until summer 2009.

b. In accordance with reference (c), the option to transfer a Service member's unused education benefits to an eligible dependent required a 4-year additional service obligation at the

time of election. All officers were required to complete and submit electronic transfer election using the MilConnect transfer of education benefits (TEB) portal after having NAVPERS 1070/613, Administrative Remarks, prepared by their command in the Navy Standard Integrated Personnel System Electronic Service Record, agreeing to serve the required additional years of service. Furthermore, the policy directed members to periodically check the status of their application; a denied TEB application required members to take corrective action and reapply with a new service obligation end date.

c. Reference (d), updated the TEB process by establishing an online, self-service Statement of Understanding that replaced the NAVPERS 1070/613, Administrative Remarks effective 1 October 2018. The Statement of Understanding must be complete by all Sailors prior to submitting a TEB application.

d. On 23 May 2014, Petitioner accepted active commission and entered active duty.

e. On 12 October 2018, Petitioner married spouse, [REDACTED]

f. On 5 August 2020, Petitioner requested a Fiscal Year 2021 [REDACTED] Retention Bonus that required a 4-year service obligation. Commanding Officer, [REDACTED] forwarded the application to [REDACTED] with a favorable recommendation on 11 August 2020.

g. On 28 August 2020, Petitioner's first child, [REDACTED] was born.

h. On 14 December 2020, Petitioner submitted TEB application without completing the required Statement of Understanding. Petitioner requested to allocate education benefits to [REDACTED]/12 months and [REDACTED] 24 months. The Service rejected the application on 15 December 2020, indicating, "Disapproved-SM [Service Member] has not committed to the required additional service time."

i. On 8 March 2023, Petitioner's second child, [REDACTED] was born.

j. On 3 December 2024, Petitioner completed the required Statement of Understanding.

k. On 3 June 2025, Petitioner submitted TEB application and requested to allocate education benefits to [REDACTED]/2 months, [REDACTED] 2 months, and [REDACTED] 2 months. The Service approved the application with an obligation end date of 2 June 2029.

CONCLUSION

Upon review and consideration of all the evidence of record, the Board finds the existence of an injustice warranting the following corrective action. Petitioner met the basic eligibility criteria to transfer Post-9/11 GI Bill education benefits but failed to complete the administrative requirements outlined in references (c) and (d). Although Petitioner did not complete the appropriate administrative requirements, the Board determined that he continues to serve and has completed 5 years of active duty service after submitting his initial TEB application on

14 December 2020, thereby meeting the spirit and intent of reference (b). Therefore, the Board determined under these circumstances, relief is warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner, in coordination with his command completed the required Statement of Understanding on 14 December 2020 and submitted it to Commander, Navy Personnel Command for inclusion in the Petitioner's Official Military Personnel File.

Petitioner elected to transfer unused education benefits to [REDACTED] r/2 months, and [REDACTED] /2 months through the MilConnect TEB portal on 14 December 2020. Note: Petitioner allocated education benefits to [REDACTED] /2 months after birth on 8 March 2023.

Commander, Navy Personnel Command (PERS-311) reviewed Petitioner's TEB application, and it was approved on 14 December 2020 with a 4-year service obligation. Note: PERS-311 will ensure Petitioner's Benefits for Education Administrative Services Tool Family Member History is updated with the aforementioned approved allocation of education benefits.

A copy of this report of proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above titled matter.

5. Pursuant to the delegation of authority set out in Section 6(e) of the revised Procedures of the Board for Correction of Naval Records (32 Code of Federal Regulations, Section 723.6(e)), and having assured compliance with its provisions, it is hereby announced that the foregoing corrective action, taken under the authority of the reference, has been approved by the Board on behalf of the Secretary of the Navy.
