1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting that his naval record be corrected to establish show Petitioner was eligible for and received a Selective Retention Bonus (SRB).

2. The Board, consisting of ██████████, ██████████, and ██████████ reviewed Petitioner's allegations of error and injustice on 12 March 2026 and pursuant to its regulations, determined that the corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval record, and applicable statutes, regulations, and policies.

3. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice finds as follows:

- a. On 6 November 2017, Petitioner entered active duty.
- b. On 23 August 2018, Petitioner was assigned Primary Military Occupational Specialties (PMOS) 0621.
- c. On 20 August 2021, Petitioner reenlisted for 4 years with an End of Current Contract (ECC) of 19 August 2025.
- d. On 1 December 2021, Petitioner was promoted to Sergeant/E-5.

e. On 6 November 2023, Petitioner entered Zone B.

f. On 14 March 2025, Petitioner's Careerist Active Duty Reenlistment request was submitted to Headquarters, U.S. Marine Corps (HQMC) requesting a 48 month reenlistment. Career Planner Comments: "SNM is an FY 25 STAP Marine who is requesting reenlistment within his PMOS and RE-30 forgiveness, at the direction of SNMS PMOS Monitor SNM is requesting forgiveness of his RE-30 and subsequent assignment of orders to [REDACTED]."

g. On 4 June 2025, Petitioner's Careerist Active Duty Reenlistment request was approved by HQMC. Approved MOS: 0621. No bonus was authorized.

h. On 6 June 2025, Petitioner reenlisted for 4 years and 3 months with an ECC of 5 September 2029.

CONCLUSION

Upon review and consideration of all the evidence of record, and especially in light of the contents of enclosure (2), the Board finds the existence of an injustice warranting the following corrective action. The Board concluded that on 14 March 2025, Petitioner's Careerist Active Duty Reenlistment request was submitted to HQMC. At the time of submission, Petitioner was eligible for a Zone B SRB in accordance with references (b) and (c). On 14 April 2025, reference (d) was published and did not authorize a Zone B SRB for 0621, E5. Furthermore, previously eligible FY25 reenlistment Marines that had not submitted for reenlistment to HQMC prior to 15 April "will not receive a bonus." Petitioner's request was not approved until 4 June 2025. On 6 June 2025, Petitioner reenlisted for 4 years and 3 months with no SRB. The Board determined that Petitioner submitted his request prior to the 15 April 2025 deadline in reference (d), and the delay in approval was no fault of Petitioner, therefore under this circumstance, relief is warranted.

RECOMMENDATION

That Petitioner's naval record be corrected, where appropriate, to show that:

Petitioner was discharged and reenlisted on 13/14 April 2025 vice 5/6 June 2025 for a term of 4 years and 5 months vice 4 years and 3 months.

Note: This change will entitle the member to a Zone B SRB for PMOS 0621, E5, which is capped at \$18,630. Remaining obligated service to 19 August 2025 will be deducted from SRB computation.

A copy of this report of proceedings will be filed in Petitioner's naval record.

4. It is certified that a quorum was present at the Board's review and deliberations, and that the foregoing is a true and complete record of the Board's proceedings in the above titled matter.
