1. Pursuant to the provisions of reference (a), Subject, hereinafter referred to as Petitioner, filed enclosure (1) with the Board for Correction of Naval Records (Board), requesting an upgrade to his reason for separation, restoration of all pay, benefits and service time lost. Petitioner is not requesting reinstatement into the service. Enclosures (1) through (2) apply.

2. The Board, consisting of ██████████, ██████████, and ██████████, reviewed Petitioner's allegations of error and injustice on 29 July 2025 and, pursuant to its regulations, determined the partial corrective action indicated below should be taken on the available evidence of record. Documentary material considered by the Board consisted of the enclosures, relevant portions of Petitioner's naval service records, and applicable statutes, regulations, and policies to include reference (b) through (d).

3. The Board, having reviewed all the facts of record pertaining to Petitioner's allegations of error and injustice, finds as follows:

a. Before applying to this Board, Petitioner exhausted all administrative remedies available under existing law and regulations within the Department of the Navy.

b. Petitioner enlisted in the U.S. Marine Corps and began a period of active duty on 14 January 2019.

c. On 8 April 2022, Petitioner was involuntarily discharged from the Marine Corps for misconduct due to misconduct (other) with an honorable characterization of service. The serious offense in question was his refusal to comply with the former COVID-19 vaccination mandate of reference (c) in violation of Article 92, Uniform Code of Military Justice.

d. Petitioner contends he was wrongfully discharged from the Marine Corps solely for refusing to receive the COVID-19 vaccine.

e. For purposes of clemency and equity consideration, the Board considered the totality of Petitioner's application; which included his DD Form 149 and the evidence Petitioner provided in support of his application.

CONCLUSION:

Upon review and consideration of all the evidence of record, the Board concludes that Petitioner's request warrants partial relief.

According to reference (d), the COVID-19 vaccine mandate was an "unfair, overbroad, and completely unnecessary burden on our Service members" and the military "unjustly discharged those who refused the vaccine." Since there was no other basis for administrative separation apparent in Petitioner's naval record, the Board therefore found an injustice in that Petitioner was involuntarily separated from the Marine Corps solely for refusing the former COVID-19 vaccination mandate.

Having found an injustice in that Petitioner was involuntarily separated from the Marine Corps solely for refusing the former COVID-19 vaccination mandate, the Board also found an injustice in any and all adverse actions that followed from or contributed to that separation.

The Board further concluded that Petitioner is not entitled to any pay, benefits, or service time lost as a result of his discharge as he did not request reinstatement per reference (b).

RECOMMENDATION:

In view of the above, the Board directs the following corrective action:

That Petitioner be issued a new Certificate of Release or Discharge from Active Duty (DD Form 214) indicating that, for the period ending 8 April 2022, he was discharged with a "Honorable" characterization of service, narrative reason for separation of "Secretarial Authority," SPD code of "JFF1," reentry code "RE-1J," and separation authority of "MARCORSEPMAN Par 6214."

That Petitioner's naval record be reviewed and any adverse information pertaining to Petitioner's refusal to comply with the former COVID-19 vaccination mandate, including but not limited to any punitive actions, administrative separation documentation, and "Page 11" entries be removed.

That no further changes be made to Petitioner's record.
