Dear Petitioner:

This is in reference to your application for correction of your naval record pursuant to Section 1552 of Title 10, United States Code. After careful and conscientious consideration of relevant portions of your naval record and your application, the Board for Correction of Naval Records (Board) found the evidence submitted insufficient to establish the existence of probable material error or injustice. Consequently, your application has been denied.

A three-member panel of the Board, sitting in executive session, considered your application on 11 March 2026. The names and votes of the members of the panel will be furnished upon request. Your allegations of error and injustice were reviewed in accordance with administrative regulations and procedures applicable to the proceedings of this Board. Documentary material considered by the Board consisted of your application, together with all material submitted in support thereof, relevant portions of your naval record and applicable statutes, regulations and policies, as well as the 16 June 2025 decision by the Marine Corps Performance Evaluation Review Board (PERB) and the 24 April 2025 Advisory Opinion (AO) provided to the PERB by the Headquarters Marine Corps Performance Evaluation Section (MMPB-23). Although you were afforded an opportunity to submit a rebuttal, you chose not to do so.

The Board carefully considered your request to modify the fitness report for the reporting period 1 January 2023 to 31 March 2023 by removing the markings assigned by the Reviewing Officer (RO). You contend the fitness report was unjustly marked due to adversity outside the reporting period. Specifically, you contend the adversity was received on 24 April 2023 and the reporting period ended 31 March 2023. Additionally, you contend the Reporting Senior marked you at the top of his profile at the time compared to the RO marking you at the bottom of his profile.

The Board, however, determined the fitness report was valid as written and filed, in accordance with the applicable Performance Evaluation System Manual. The Board, concurring with the AO, noted the report does not contain any derogatory information nor does it reference any events associated with the 24 April 2023 counseling entry. Further, the Board concurred that a marking in the "3" block is not considered adverse. The Board concluded the RO appropriately utilized the opportunity to compare your performance against other Marines of the same grade. Based on the available evidence, the Board concluded there is insufficient evidence of an error or

injustice warranting modification of the fitness report. Accordingly, given the totality of the circumstances, the Board determined your request does not merit relief.

You are entitled to have the Board reconsider its decision upon submission of new matters, which will require you to complete and submit a new DD Form 149. New matters are those not previously presented to or considered by the Board. In this regard, it is important to keep in mind that a presumption of regularity attaches to all official records. Consequently, when applying for a correction of an official naval record, the burden is on the applicant to demonstrate the existence of probable material error or injustice.
